RE: Renewal of Elections Computer Contract

Dear Members of the Board,

In March 1984, your Board approved the purchase of a stand-alone computer system for the Elections Department. A copy of that original contract is on file with the Clerk of the Board. Part of the contract includes a five-year agreement with DFM Associates to provide and maintain the system software.

This agreement was last extended by your Board in 1994 for an additional five-year period. That extension recently expired and an amendment needs to be endorsed to extend the contract another five years. DFM Associates has provided an amendment for your approval. The agreement maintains the clause that allows either party to terminate the agreement after a 60-day notice.

During the last ten years we have had virtually no down time, and DFM Associates has provided excellent support and made numerous upgrades to the software to improve our efficiency. In addition, the firm provides training at no additional cost, and regularly hosts user meetings for all their customers. (17 counties), which have been very beneficial.

It is therefore RECOMMENDED that your Board approve a five year extension of the contract with DFM Associates and direct the County Administrative Officer to sign the enclosed Lease Agreement Modification extending the Election Computer Lease to June 30, 2004.
