RE: APPOINTMENTS TO SPECIAL DISTRICTS

Dear Members of the Board:

Attached are 3 resolutions calling for the appointment of unopposed candidates who filed Declarations of Candidacy with the Elections Department for the following districts:

- O Place de Mer Geologic Hazard Abatement District
- O Alba Park, Parkway and Recreation District
- Opal Cliffs Recreation District

Due to an insufficient number of candidates, the special districts will not appear on the November 2, 1999 ballot.

Pursuant to Elections Code Section 10515, the Board of Supervisors is required to make appointments prior to Monday, December 6 at a regular or special meeting of your, Board. Candidates to be appointed are listed in attached resolutions.

Also, pursuant to Elections Code Section 10515 the Board of Supervisors is required to appoint qualified persons to fill the vacant positions on the special district boards for which no one filed. The vacancies that need to be filled on November 2, 1999 are:

Pajaro Valley Fire Protection District

I have notified the special district of the existing vacancies and have provided the district with a notice to be posted and applications for interested persons. Applications will be forwarded to your Board for appointment.

Page 2 - Appointments

For your information, Aromas Tri-County Fire Protection District was also scheduled for election on November 2, 1999; however, it too had an insufficient number of nominees. Its candidates will be appointed in-lieu by San Benito County, the controlling county for that district.

Therefore, the only elections taking place in Santa Cruz County on November 2, 1999 is the Pajaro Valley Unified School District - Trustee Area 6 Special Election and the Salsipuedes Sanitary District Election. The county Elections Department will conduct the election on the district's behalf. All county costs associated with conducting the election will be paid for by the districts.

It is recommended that the Board of Supervisors adopt the resolutions appointing the unopposed special district candidates who have filed Declarations of Candidacy for the November 2, 1999 Election.
