Proposed POST Financing Of Multi Media Computer System
 For Law Enforcement Training

Dear Members of the Board:

The California Commission On Peace Officers Standards & Training (POST) has offered California law enforcement agencies a special program to reimburse the costs of obtaining multimedia computer systems dedicated to the delivery of State mandated training to meet State training requirements for law enforcement officers.

In an effort to take advantage of new technology and to reduce costs, POST has agreed to provide selected training on compact computer discs for distribution and presentation at local law enforcement training sites.

As your Board may recall, at your February 9, 1999 meeting you approved the purchase of a POST funded multi media computer system for the Personnel & Training section of the Sheriff's Office. This system is currently being used to facilitate in-house training for Sheriff's Office law enforcement staff.

On August 4, 1999 we received POST approval to fund a second multi-media computer system which will allow the Sheriff's Office to expand its training capabilities as well as implement an automated training records management system which tracks employee completion of mandated POST training for law enforcement purposes.


POST has agreed to reimburse the Sheriff's Office \$2,764 of the total price of \$2,894 for an IBM computer which meets County standards and which can be supported by County Information Services. Existing appropriations within the Sheriff's Office FY 99/00 Administration Bureau budget are sufficient to fund the

remaining \$130 needed to fully finance this purchase.

Therefore, it is Recommended that your Board:

1. Adopt the attached resolution accepting and appropriating unanticipated revenue in the amount of \$2,764 from the California Peace Officers Standards and Training to finance the purchase of a computer based multi media training system.
2. Approve the purchase of a County standard IBM computer at a cost not to exceed \$2,894.40 (specifications attached).




