APPROVE CABRILLO COLLEGE JOB TRAINING PARTNERSHIP ACT (JTPA) FAST TRACK TO WORK SERVICES CONTRACT FOR PY 1999-2000

Dear Members of the Board:

On May 27, 1999, the Interim Workforce Investment Board/Private Industry Council approved JTPA PY 1999-2000 funding recommendations including \$58,753 for the Cabrillo College Fast Track to Work services contract. The purpose of this letter is to seek your Board's approval of the contract with Cabrillo College and to authorize the Human Resources Agency Administrator to sign the contract.

Cabrillo College's Fast Track to Work program will provide JTPA CareerWorks adult program participants, ages 22 and above, and laid off workers, with professional and matriculation services that include, but are not limited to: early and priority registration assistance, individual and career guidance counseling, attendance tracking, academic progress reporting, and tutoring. For participant accessibility, Cabrillo College will maintain regular office hours at each of the Workforce Santa Cruz County Career Centers. The program is 100% federally funded; therefore, there is no County cost. A copy of the contract is on file with the Clerk of the Board.

IT IS THEREFORE RECOMMENDED that your Board:

- 1. Approve the Fast Track to Work contract with Cabrillo College for \$58,753 on file with the Clerk of the Board; and
- 2. Authorize the Human Resources Agency Administrator to sign the contract.
