#### SUBJECT: BROMMER MAINTENANCE YARD ROOF PROJECT AWARD OF CONTRACT

Members of the Board:

On August 24, 1999, the Board of Supervisors received one bid for the Brommer Maintenance Yard Roof Project. All bids were found to be in order. The engineer's estimate was \$70,000. The low bidder was **Cunnings &** Cunnings, Inc., of Fresno in the amount of \$47,282. Sufficient funds are available in the 1999/2000 road budget to cover this expenditure plus contingencies and inspection.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Accept the low bid of Cunnings & Cunnings, Inc., in the amount of \$47,282 and authorize the award of the contract,
- 2. Authorize the Director of Public Works to sign the contract on behalf of the County.
