### Approve Agreement with Fouts Springs Ranch Youth Facility


Dear Members of the Board:

The Santa Cruz County Probation Department contracts with several counties for court ordered placement of wards in Ranch Camps. The Department currently contracts with Colusa and Solano counties for placement in Fouts Springs Youth Facility, at a cost of \$2,600 per month.

Fouts Springs has imposed a rate increase of \$100 per month effective July 1, 1999. All other terms and conditions remain the same. The annual amount of \$60,414, as shown in Section I of the continuing agreements list for this Fiscal Year 1999-2000 is appropriated in the Care of Court Wards budget.

IT IS THEREFORE RECOMMENDED that your Board approve the attached ADM29 Request for Approval of Agreement, encumbering \$60,414 from funds available in appropriations account 577000-3665, Professional and Specialized Services, and contract with Colusa and Solano counties for placement of Santa Cruz County wards at a rate of \$2,700 per month effective July 1, 1999, and authorize the Chief Probation Officer to sign the agreement on behalf of the County.
