**RE:** Replenishment of Cash Difference Fund

Dear Members of the Board:

As provided for in Resolution #806-59, \$100 was established as a cash difference fund for use by the Treasurer, Central collections and the Tax Collector. Authorization is now requested for the replenishment of this county officer's cash difference fund. The fund is used to replenish shortages caused by forgeries and cash handling errors in all three divisions.

Since December 1995, when the last replenishment occurred, this fund has had a shortage of \$1.00 in the Collections Division and a shortage of \$3.05 in the Treasury. In addition, a counterfeit \$100.00 bill was deposited to the Treasury on September 3, 1999. The amounts and dates of all these transactions are on file in this office and are open to review by the Auditor. The current fund balance is <\$4.05>.

THEREFORE IT IS RECOMMENDED, the Board of Supervisors approve the attached resolution providing for the replenishment of the Treasurer-Tax Collector's Cash Difference Fund and request the Auditor to issue a warrant in the amount of \$104.05.
