RE: WAIVER OF DISPOSAL/LANDFILL FEES--MESA VILLAGE
NEIGHBORHOOD CLEANUP

Dear Members of the Board:

The purpose of this letter is to request a waiver of the disposal fees that Waste Management of Santa Cruz County will incur as a result of the Mesa Village Neighborhood Cleanup on October 23, 1999. I am requesting that this matter be placed on the consent agenda of the October 19, 1999, meeting of the Board of Supervisors.

Recently a Neighborhood Watch was established with the support of the Sheriff's Department P.O.P. The Mesa Village Neighborhood Watch meets on a regular basis, along with the Deputies from the Sheriff's substation in Freedom, to attempt to foster safe neighborhoods and to tackle the problems of gangs, graffiti and the like. It is heartening to see not only the commitment from the Sheriff's Department, but also from the pride that the families take in their neighborhood. To that end, on Saturday, October 23, 1999, from 9:00 a.m. to 3:30 p.m., a neighborhood cleanup at Mesa Village is being sponsored by Waste Management of Santa Cruz and the County of Santa Cruz.

Waste Management of Santa Cruz has generously agreed to donate all costs for the dumpsters, trucks and labor, including overtime, as it will entail working on Saturday. Ten dumpsters will be situated throughout the Mesa Village neighborhood. Two drivers will be available throughout the day to transport dumpsters to the landfill and return them to the neighborhood for further use. Residents of the neighborhood are strongly encouraged to recycle everything possible. Fortunately, the recycling fees for mattresses, tires, asphalt, brick, and



concrete at the Buena Vista Landfill will be waived from October 16-24, 1999. Flyers have been generated by Public Works in both Spanish and English, informing the residents of this important message on recycling. (See attached.)

Jim Morasco exemplifies the benevolence of corporate citizens committed to our community. However, in this instance he will be able to do so only with our assistance. Moreover, this provides yet another opportunity for the private and public sector to work collaboratively in providing services to the residents of the County of Santa Cruz. I am recommending that on October 19, 1999, the Board of Supervisors vote to waive the disposal fees that Waste Management of Santa Cruz County will incur during the disposal of the waste from the Mesa Village Neighborhood Cleanup on October 23, 1999.

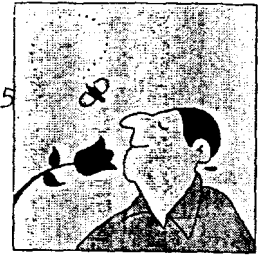

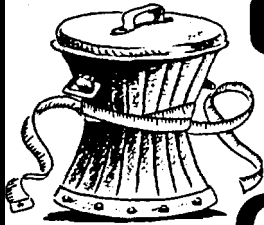

RECYCLING FEES WAIVED at the BUENA VISTA LANDFILL and the BEN LOMOND TRANSFER STATION

*All residents of Santa Cruz County and the
Cities of Watsonville, Capitola and Scotts Valley are eligible.*

The following items will be accepted free of charge at the Buena Vista Landfill and the Ben Lomond Transfer Station from Saturday, October 16, through Sunday, October 24:

- ⊕ Clean sorted **YARDWASTE & WOODWASTE**, no painted or treated wood, maximum size 8' in length and 2' diameter, no rootballs (Residential loads only).
- ⊕ **APPLIANCES & SCRAP METAL** accepted year-round at no charge (no auto' bodies).
- ⊕ **AUTO TIRES**, less than 36" in diameter (limit — 5 per residential customer).
- ⊕ **MATTRESS** and **BOX SPRINGS** (limit — 4 per residential customer).
- ⊕ Clean sorted **CONCRETE, BRICK** or **ASPHALT** (Residential loads accepted at Buena Vista Landfill only.)

All other landfill fees will remain in effect during Clean-Up.

Note: NO FREE TRASH PICK-UP OR DISPOSAL

YEAR-ROUND SERVICES

Bulky Item Pick-up By Appointment

- Large appliances, refrigerators, and furniture.
- \$17 charge per item during Clean-up Days (normally \$20).
- Pick-up by appointment only. Call Waste Management at 1-800-665-2209 to schedule an appointment. No need to be a Waste Management customer, but must be a resident of the Unincorporated County, City of Capitola or Scotts Valley.

Please Recycle First!

- ⊕ No charge recycling options are available every day. Call 454-2333 for recorded information on the recycling center nearest you.
- ⊕ Metals, glass & plastic containers, newspapers, cardboard, and other materials accepted daily at no charge at all landfill and transfer station recycling centers.
- ⊕ Household hazardous waste such as paint and pesticides are accepted at HHW facilities free of charge. Call 454-2606 for more information and hours of operation.

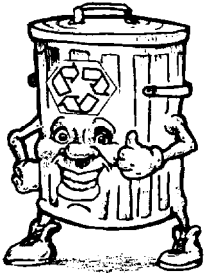

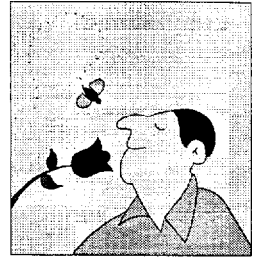
