**Re: Resolution Amending Unified Fee Schedule to Include Fee for Collection of Court-Ordered Restitution Pursuant to Penal Code § 1202.4(l)**

Dear Members of the Board:

This is to submit a proposed resolution amending the Unified Fee Schedule to include imposition of a fee for collection of Court-ordered restitution pursuant to Penal Code § 1202.4(l). This section states that a County may impose a fee for the actual administrative cost of collecting a restitution fine included in the Court order, not to exceed 10% of the amount ordered to be paid, the proceeds to be deposited in the general fund.

IT IS THEREFORE RECOMMENDED that your Board set a public hearing on November 9, 1999, at 9:00 a.m. to consider adoption of the attached resolution amending the Unified Fee Schedule to include a 10% collection fee for the actual administrative

cost of collecting Court-ordered restitution pursuant to Penal Code §1202.4(1).

RESOLUTION AMENDING THE UNIFIED FEE SCHEDULE TO INCLUDE TO  
IMPOSE A 10% FEE FOR COLLECTION OF COURT-ORDERED RESTITUTION  
PURSUANT TO PENAL CODE § 1202.4(l)

WHEREAS, the Board of Supervisors has previously enacted Resolution No. 537-82 wherein it was determined to consolidate the fees previously authorized for collection by the Board, by resolution or ordinance, into one unified schedule;

WHEREAS, Penal Code § 1202.4(l) provides that the board of supervisors of any county may, in its discretion, impose a fee to cover the actual administrative cost of collecting the restitution fine, not to exceed 10% of the amount ordered to be paid, to be added to the restitution fine and included in the order of the court, the proceeds of which shall be deposited in the general fund of the county;

WHEREAS, the Board of Supervisors has determined that a 10% collection fee should be imposed on any restitution fine ordered by the Court pursuant to Penal Code § 1202.4 in order to cover the administrative cost of collecting the restitution fine;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that a 10% collection fee is imposed pursuant to Penal Code § 1202.4(l) to cover the actual cost of collecting the restitution fine and the Unified Fee Schedule is amended to include this collection fee.


