Dear Members of the Board:

Section 18.10.350 of the Santa Cruz County Code allows members of the Board of Supervisors to request that the Board set a planning item for special consideration before the Board. This letter is to request that the Board of Supervisors set for special consideration Application No. 97-0648 by John and Brenda Stephenson to construct a private equestrian facility. Facilities are to include an agricultural barn of 8,000 square feet and associated paved driveway and parking/circulation area, five 4,975 gallon water storage tanks, use of an existing well and 86 gallon water storage tank for the horse barn and landscaping purposes, and grading of 840 cubic yards of earth. I understand that the Assessor's parcel number is 59-021-03/62-151-03. The Planning Commission approved this application on September 22, 1999.

I believe that the Board should consider this matter under Section 18.10.350 because there is significant neighborhood concern about the project. The project is located on the highest knoll of the upper-terrace of the parcel and will be visible from Wilder Ranch State Park. There are also serious questions regarding runoff of coliform and other bacteria into Laguna and Majors Creeks.

In order to make certain that adverse neighborhood and public impacts are not experienced because of the approval of this project, I believe the Board should consider the matter under special consideration.
