APPROVAL OF CONTRACT FOR RECEPTION SERVICES FOR WORKFORCE SANTA CRUZ COUNTY WATSONVILLE AND MIDCOUNTY CAREER CENTERS

Dear Members of the Board:

As you may recall, your Board on February 10, 1998 approved a contract with the Employment Development Department (EDD), a partner in Workforce Santa Cruz County, to provide reception services at the Watsonville Career Center. EDD has agreed to continue to provide reception services at the Watsonville Career Center and to begin to provide reception services at the Mid-County Career Center. A contract with the Human Resources Agency CareerWorks Division for the period July 1, 1999 through June 30, 2000 in the amount of \$110,363 will finance both positions. The purpose of this letter is to request your Board's approval of the contract with EDD and to authorize the Human Resources Agency Administrator to sign the contract.

At the Watsonville Career Center EDD has been providing reception services since January 1998 for all the Centers' partners. The costs of the reception services will continue to be paid by the partners and programs in the Center. Mid-county Career Center reception costs will be funded by the Job Training Partnership Act (JTPA). There are no County costs associated with this contract. The contract is on file with the Clerk of the Board.
