> RE: PROPOSED NEW STOP SIGN ON RIO DEL MAR BOULEVARD AT PALMER AVENUE

Dear Members of the Board:

In order to improve traffic operations, the residents of the Rio Del Mar Improvement Association have requested a new multi-way stop sign at the Rio Del Mar Boulevard and Palmer Avenue/Spanish Bay Drive intersection. Although the proposed stop signs do not meet State stop sign warrants, the proposed multi-way stop signs will provide greater access for residents who reside on Palmer Avenue and Spanish Bay Drive. In addition, this intersection serves as the primary pedestrian access point from Palmer Avenue to the Rio Del Mar Boulevard pedestrian walkway that connects with the Deer Park Shopping Center.

Accordingly, I recommend that the Board adopt the attached ordinance in concept for the installation of new multi-way stop signs at the Rio Del Mar Boulevard and Palmer Avenue/Spanish Bay Drive intersection and place the ordinance on the next available agenda for final adoption.

### ORDINANCE AMENDING CHAPTER 9 OF THE SANTA CRUZ COUNTY CODE RELATING TO STOP INTERSECTIONS

#### SECTION I

Section 928.30 - Multi-way stop intersections designated, is hereby amended by amending paragraph R.1. as follows:

R. 1. Rio Del Mar Boulevard, and:

a. Palmer Avenue and Spanish Bay Drive,

**b.** Sumner Avenue (three-way);

## SECTION II

This Ordinance shall take effect on the 3 1 st day after the date of final passage.
