Approve Amendments to Agreements with Pajaro Valley Prevention and Student Assistance, Inc., for Probation Programs, and Take Related Actions

Dear Members of the Board:

The Probation Department utilizes Pajaro Valley Prevention and Student Assistance, Inc. (PVPSA) to provide supportive services for both the Juvenile Drug Treatment Court in **Watsonville** and the High Risk Youth Continuum of Services (JUNTOS) Program.

The current agreement for supportive services to the Juvenile Drug Treatment Court in Watsonville provides for a halftime, bilingual drug/alcohol youth counselor, a halftime, bilingual youth development specialist, and an array of specialized drug and alcohol services for program participants. The attached amendment A- 1 to Agreement #8 1766 extends the agreement through **June 30, 2002**, and increases the annual amount payable to PVPSA from \$60,000 to \$77,250, an increase of \$17,250. The revised amount was included in the Probation Department's continuing agreements list for FY 1999-2000. Costs for the program are included in the Probation Department's Temporary Assistance to Needy Families (TANF) allocation and program plan. There is no increase in net county cost as a result of the issuance of this amendment.

The agreement with PVPSA for services under the High Risk Youth Continuum of Services (JUNTOS) Program was funded through a grant awarded by the State Office of Criminal Justice Planning (OCJP) that was scheduled to terminate June 30, 1999. Due to roll-over of unexpended funds, OCJP extended the agreement for one month, through July 31, 1999. The attached amendment A-1 to Agreement #81309 extends the sub-contract with PVPSA for that one month, and increases the total amount payable **from** \$173,802 to \$199,624, an increase of \$25,822. PVPSA provided counseling and educational services as well as alternative activities and programs for juveniles and their families under the JUNTOS program. There is no increase in net county cost as a result of the issuance of this amendment.

IT IS THEREFORE RECOMMENDED that your Board:

- 1) Approve and authorize the Chief Probation Officer to sign Amendment A- 1 to Agreement #81766 with Pajaro Valley Prevention and Student Assistance, Inc. for Juvenile Drug Treatment Court supportive services, extending the term of the agreement to June 30, 2002 and increasing the annual amount payable to \$77,250; and
- 2) Approve the attached ADM 29 Request for Approval of Agreement, encumbering an additional \$25,822 **from** funds available in appropriations account 574100-3665, Professional and Specialized Services, and extending Agreement #8 1309 with PVPSA for the JUNTOS Program for one month, through July 3 1, 1999; and authorize the Chief Probation Officer to sign Amendment A- 1 on behalf of the County.
