SUBJECT: BID AWARD - SIDEWALK ACCESS RAMPS 1999

Members of the Board:


The Board of Supervisors received seven bids for the subject project on November 16, 1999. One of the bids was incomplete, but the other six have been checked by the Department of Public Works and found to be in order. The low bid was submitted by BDS Construction, Inc., of Madera in the amount of \$219,830. The engineer's estimate was \$260,000.

The funding for the ramp portion of the project, in the amount of \$206,736, is provided by the various roadside improvement funds. The funding for the construction of sidewalks on Playa Boulevard in La Selva Beach, in the amount of \$13,094, is provided by the Road Fund.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of BDS Construction, Inc., of Madera in the amount of \$219,830 and authorize the award of the contract.
2. Authorize the Director of Public Works to sign the contract on behalf of the County of Santa Cruz.


