Members of the Board:

As directed by your Board on August 24, 1999, we present today the Zone 5 District Engineer's recommendations for Capital Improvement Program project priorities (Exhibit "A").

The recommendations have been divided into "funded" and "unfunded" projects based upon estimated funds available to undertake the improvements for the next ten years. The criteria for prioritization are overall benefit and severity of existing drainage problems to be mitigated. The attached Recommended Drainage Improvements list (Exhibit "A") shows that the first project would be Bostwick Lane to be designed and built in 1999/2000. Each year thereafter would see one or more projects designed and built depending on funding availability in a particular year.

It is therefore recommended that the Board of Directors approve the Zone 5 Capital Improvement Program drainage project list.
