Dear Mr. Hurst:

Effective immediately, you are suspended from the Sheriffs Office Posse. I am also recommending that the Posse Board of Directors move forward to remove you from the Posse.

This action is based on the following:

- Your removal from the Posse on a prior occasion for conduct that was detrimental
 to the best interest, welfare, standing, goodwill, fellowship reputation or good
 name of the Posse.
- Your reenstatement to the Posse a year ago with the understanding that you would conduct yourself in a manner appropriate for membership.
- Your arrest by the C.H.P. on November 31, 1998, for driving while intoxicated.
- Your failure to notify the Sheriff or any Posse Board Members of the arrest.
- Your acceptance of position on the Posse Board of Directors as Sergeant of Arms while knowing that you failed to inform the Sheriff or the Posse Board of your pending criminal case.
- Your unwillingness to address your obvious problem with over consumption of alcohol.

Your suspension includes your involvement in Sheriffs Office functions or wearing of the uniform or badge. The suspension is permanent. You will surrender your badge to the Deputy who serves you with this document.

Dear Sheriff Tracy,

Our Deputies served your letter this evening. Took me quite by surprise. Although, I did not tell you personally of my terrible situation, something you said at the next Posse meeting made me believe you were aware. I feel very comfortable with the Posse's board and would have discussed it with Herb Ross or Deb Tracy, had I not thought you were aware of the allegations. So, I thought you were being kind and trying to save me the embarrassment. Remember me asking if you were comfortable with me doing a DARE activity with this hanging over my head?

I am very sorry to have let down and disappointed my fellow Posse members and my many friends in the Posse.

In your letter you called attention to 5 points to qualify your actions and recommendation to the board, however you stated several falsehoods. First of all, I was at no time removed from the Posse. August 30,1994 I resigned upset over the fact that my dating of Christina Martin had become a public issue, and the way it was handled. Secondly, I was reenstated to the Posse in excess of 3 years ago, which gives me 15 years of dedicated service with a brief 8 month leave of absence. Upon my reenstatement I, as all Posse members do, agreed to adhere to the By-Laws and it was also agreed, that since more of the previous situation was now understood as was my reason for resigning that these issues would not be brought up again and my resignation would be

considered a Leave of Absence.

This would be a horrible smear on my record, if found guilty, yet I can truely say my behavior while in uniform has always been above reproach. Please ask any of the Posse members I have been on Mall Patrol with or those I have ridden with on search and rescue assignments.

I truely wish you would meet face to face and reconsider putting myself and Our Posse in this position.

Dear Deb and Fellow Board Members,

I was instructed not to attend the board meeting of May 13,99, it was thought that Sheriff Tracy wanted to address the board and my presence would be awkward. In agreeing to this politeness, I was promised my response to Sheriff Tracy's letter would be read. It was not. Additionally, I presumed I would be heard before a vote would be taken.

I am not reconizing the vote taken, since it is in direct conflict with Sheriff Tracy's request and Robert's Rules of Order. Our By-Laws do state that, the member being removed must appear before the board. Robert's Rules state that my own vote, as a board member, is still valid until after my removal.

I must also state that, there are few men I respect as I do John Barnes. This aside, our by-laws do not allow for appointments of Officers, and Robert's Rules specifically oppose the idea. Therefore, of our 7 member board only 4 were in attendance, I believe this would have change the outcome.

My wish at this time would be to set aside the illegal vote taken and to either hold a special board meeting or wait until the next regular board meeting, at such a time I would be allowed to state my side.

Ofcourse the By-Laws allow for trial before the entire membership, I believe we would all like to avoid that option.

Dear Members of the Board,

I must apologize for misstating Article 6 in my last letter to you. As Deb Tracy and I discovered over the phone, I was using a 11/96 revision of the By-Laws, unaware the 7/98 revision took out membership protections. Notwithstanding that error, or perhaps using it to prove my point, I must ask you to revisit what the Posse is becoming.

I am hereby informing you, that I would like to assert my Article 6 right to address the membership. My reasons for the appeal are as follows:

- 1. The board's only stated reason is Sheriff Tracy demanded it. Sheriff Tracy's letter says recommending.
- 2. At least 4 elements of our by-laws and constitution were ignored during this procedure.
- 3. It was a known fact, that this was an allegation, not a conviction.
- 4. It was known to the Sheriff that, there was a urine test result of .06 BAC. Below DUI levels.
- 5. The Sheriff and His Board, after swearing to uphold the Constitution of the United States, blatantly ignored "Innocent until proven guilty".

This letter is to advise you that per the Santa Cruz County Sheriffs Posse Constitution and Bylaws, Article six: Section 1- Removal of members, your membership in the Santa Cruz County Sheriffs Posse has been permanently suspended. The board regrets having to take this action, however as per Sheriff Tracy's letter to you of April 23, 1999 he placed you on immediate and permanent suspension Because of Sheriff Tracy's action, we have no recourse but to terminate your membership.

As you are aware in the bylaws you have an appeal recourse. Article six: Section I states, In the event of such vote to expel, the expelled member shall lose membership in the Posse and shall be so notified by the President. The member may appeal to the full membership by written notification to the President within thirty (30) days of the decision by the Board of Directors. The regular membership shall vote and the decision shall be by majority ballot. In the event the majority vote is to expel, the expelled member shall lose membership without recourse. The President will notify the expelled member by writing by certified mail.
