Re: RECOMMENDATION OF AWARD FOR 1020 EMELINE HVAC REPAIRS, 99C1-003

Members of the Board:

At the December 7,1999 Board meeting, bids were received for the 1020 Emeline HVAC Repairs project. Your Board directed the General Services Department to review bids and return on or before January 11, 2000 with a recommendation for award.

As directed, bids received have been reviewed and we believe that the lowest bidder, Cold Craft, Inc. with a bid of \$8,395 can accomplish the work to the County's satisfaction.

Sufficient funds are available in the General Services Facilities Budget, Index 333300/ G3 1002, Sub Object 3405, including a ten (10) per cent contingency.

It is therefore RECOMMENDED that your Board:

- Award a contract to Cold Craft, Inc. in the amount of \$8,395 for the 1020 Emeline 1. HVAC Repairs project; and
- 2. Authorize the General Services Director to notify the contractor and sign the contract agreements and associated documents on behalf of your Board; and

3. Authorize the Director of General Services to approve change orders and appropriate \$840 in addition to the contract amount to cover change order expenditures, as required.
