I. ROLE OF COMMISSION

The duties of the Commission shall be: (1) to hear appeals of Poundmaster Orders and of denials of unaltered animal certificates issued by the Poundmaster; (2) to exercise any other responsibilities set forth in the By-Laws, as approved by the Board of Supervisors.

II. MEETING DATES

Upon receipt of the appeal, the Clerk of the Commission shall set the matter for hearing not less than five nor more than forty-five days after the date the appeal is received by the Clerk

III. COMMISSION STRUCTURE

The Animal Nuisance Abatement Appeals Commission consists of members appointed by the Board of Supervisors, one from each district.

IV. COMMISSION STAFF

The Animal Nuisance Abatement Appeals Commission is staffed by the Clerk of the Board of Supervisors and by County Counsel.
