### **REQUEST FOR APPROVAL OF CALIFORNIA DEPARTMENT OF EDUCATION AMENDMENT TO AGREEMENT F2AP-9263**

Dear Members of the Board:

As you know, the Human Resources Agency (HRA) contracts with the California Department of Education (CDE) to provide subsidized child care services to eligible families in Santa Cruz County, including CalWORKs Stages 2 and 3 child care services. In August your Board approved contracts for these services for the 1999-2000 fiscal year. The purpose of this letter is to request that your board approve an increase in the amount of one of the contracts for child care services which will also provide funds for child care services for families who are moving towards self-sufficiency.

Agreement F2AP-9263 provides Stage 2 child care subsidies for CalWORKs participants whose welfare to work activities and child care needs have stabilized and for those transitioning off cash grants. The additional amount available for these services through this amended agreement is \$142,377, for a total contract amount of \$380,517. The Funding Terms and Conditions for this agreement have also been amended to clarify eligibility criteria. The amended contract along with the funding terms and conditions, which describe the requirements for the agreement, are on file with the Clerk of the Board. Funds were allocated for these services in the 1999-2000 Human Resources Agency budget, and therefore, no additional budgetary action is required.

The amended agreement with the Department of Education, as described in this letter, will provide for essential supportive services to assist families in our community. IT IS THEREFORE RECOMMENDED that your Board adopt the Resolution certifying your Board's


