The subject project was completed on August 27, 1999. The contractor was Granite Construction Company of Watsonville.


The original bid price was \$237,800.00. Total construction cost is \$240,873.36. A summary of final costs is attached for your information. The increased cost was due to additional excavation and debris removal at contract unit costs. Sufficient funds are available in the 1999/2000 Road Maintenance Budget to cover this increase.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the improvements and approve the final cost.
2. Authorize the Clerk of the Board to file the Notice of Completion, a copy of which is attached.
