

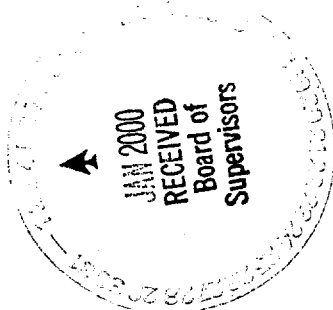

Statement of Qualifications
