SUBJECT: COUNTY SERVICE AREA NO. 54, **SUMMIT** WEST

Members of the Board:

Public Works is in receipt of \$14,000 from Mt. Charlie Waterworks. These monies represent a partial repayment of a loan between CSA No. 54 and Mt. Charlie Waterworks. As your Board may recall, the water system was transferred to CSA No. 54 by way of eminent domain. The water system is still operated by the court appointed receiver; however, it is anticipated that an operational agreement with an independent contractor will be brought to your Board for review and approval sometime in the near **future**. In the meantime, in order for the \$14,000 to be available in the 1999/00 budget, it will now be necessary for your Board to accept these monies as unanticipated revenues.

It is therefore recommended that your Board adopt the attached resolution accepting unanticipated revenue in the amount of \$14,000 from Mt. Charlie Waterworks into the CSA No. 54 Summit West budget.
