REQUEST FOR RE-ALIGNMENT OF BUDGET APPROPRIATIONS

Dear Members of the Board:

Durning the 1999/2000 Budget process, your Board approved funding in the amount of \$3,090 for equipment to enable the General Services Equipment Division staff to accurately measure and adjust the air volume output of heating, ventilation, and air conditioning (HVAC) systems in County facilities.

The funds were initially appropriated into the small tools and instrument (Sub object 3825) in the belief that the equipment comprised a number of items that would be individually acquired. The flow measuring equipment exceeds the services and supply limit of \$1,500; therefore, the General Services Department is requesting a re-alignment of funds to accurately reflect the purchase as a fixed asset.

It is therefore recommended that your Board approve the attached AUD 74 to transfer appropriations from Index 333300, Sub object 3825 to Index 333300, Sub object 8404.
