AUTHORIZATION TO APPLY FOR 2000-2001 TITLE II RYAN WHITE CARE Re:

ACT FUNDS

Dear Board Members:

The Health Services Agency is requesting authorization to apply for continuation funding from Title II of the Ryan White Comprehensive AIDS Resources Emergency (CARE) Act for the period April 1, 2000 through March 31, 2001. Title II of the Rvan White Act provides access to various health and social services for low-income persons with HIV infections. Although the application deadline is February 9, 2000, the State has not yet released the final 2000 - 2001 allocation amount. The State has informed HSA that the allocation will 'be equal to or approximately 5% less than the current allocation of \$117,691. The completed application will be placed on file with the Clerk of the Board on or before February 9. This letter also requests authorization for HSA to take related actions in connection with the State revenue agreement and Title II service agreements, as described below.

To receive Title II funds, the County must submit a formal application to the State reflecting local needs as determined by the Santa Cruz County HIV Services Services are based on recommendations by the Consortium. The County, as the Consortium's fiscal agent, develops and administers contracts for the recommended services. The Consortium has finalized its recommendations, and the existing agreements with the Santa Cruz AIDS Project (SCAP) and Food and Nutrition, SCAP's services include a medical assistance Inc. will be renewed for 2000-2001. fund, benefits advocacy, psychosocial case management, and an emergency rent/utility SCAP's 1999-2000 contract amount was assistance fund for program clients. Food and Nutrition, Inc. provides home-delivered meals for HIV/AIDS \$102,691. clients through its Meals on Wheels program, with a 1999-2000 contract amount of

\$3,231. Meals on Wheels retains three slots on a continuous basis for persons with HIV.

HSA is requesting authority to negotiate and sign these renewal agreements provided there are no major changes in services and the individual contract amounts vary no more than 10% from the 1999-2000 amounts. As in previous years, HSA is also requesting authority to execute contract amendments as needed to reflect minor program changes during the course of the new funding cycle or funding adjustments of up to 10% of the original contract amount. Total available funding will not be exceeded even if adjustments are required. Such adjustments and changes may be necessary because of revised funding priorities by the local HIV Services Consortium or to accommodate State revisions. These service agreements are not County funded, and any changes would be within current State funding limits and State contractual authorization. HSA will return to your Board if there are substantive service changes, changes in contract amount greater than 10%, or if new contractors are to be added.

The County is authorized to retain 10% of the Title II funding award to offset administrative costs for acting as the Consortium's fiscal agent, as permitted by Title II funding regulations. If the 5% funding reduction occurs, it is recommended that HSA absorb the cut (amounting to \$5,885) within this administrative allowance rather than reduce direct services to clients. The funding application will also include the current State required Memorandum of Understanding between the County and the Consortium which structures the Consortium's duties in establishing local funding priorities and the County's duties as the Consortium's fiscal agent. The 2000-2001 MOU will have only minor changes and updates from the current year's document.

Title II continuation funding for the April 1 - June 30, 2000, period was anticipated and is included in the 1999-2000 adopted County budget. The balance of the funding award will be included in HSA's 2000-2001 budget request.

It is therefore RECOMMENDED that your Board:

- 1. Authorize the Health Service Agency Administrator to submit the application for 2000-2001 Ryan White CARE Act Title II funding and to sign the required certifications.
- 2. Authorize the HSA Administrator to negotiate and sign Title II Consortium services agreements with the Santa Cruz AIDS Project and Food and Nutrition, Inc. for the period April 1, 2000 through March 31, 2001 and to execute contract amendments reflecting minor service changes or funding adjustments of up to 10% of the original contract amount.
- 3. Authorize the HSA Administrator to sign the 2000-2001 Memorandum of Understanding with the local HIV Services Consortium.



4. Authorize the HSA Administrator to sign the Title II State revenue agreement for 2000 - 2001 when received.
