Financing of a Portion of Brommer Street Improvements

Dear Members of the Board:

In a separate item on today's agenda, the Public Works Department is requesting approval of Change Order No. 2 for the Sidewalk Access Ramps 1999 Project now under construction. As explained in the letter from Public Works, approval of this change order offers the County the opportunity to obtain the right-of-way necessary to construct planned improvements on Brommer Street at the northwest corner of the intersection of 1 7th Avenue at no cost to the County, in exchange for the construction of these improvements at this time. In order for the funds necessary to award this change order to be available a parallel action is required from you, as the Board of Directors for the Redevelopment Agency.

The planned improvements are consistent with the Board adopted **planline** for Brommer Street and include curb, gutter and sidewalk, a retaining wall and fencing. This work is being financed by the Redevelopment Agency. The Redevelopment Agency's cost for the construction of these improvements, including overhead and inspection is \$43,841 .OO. Adequate funds for this project have been set aside within the Agency's multi-year project funds. However, in order to award this change order during the current fiscal year and continue design work on other portions of this project it will be necessary to appropriate an additional \$35,000 in Index 611177. A Resolution authorizing that transfer is included as Attachment 1.

Redevelopment Agency staff has determined that the improvements planned in the Brommer Street improvements are of benefit to the Project Area, that no other reasonable means of financing the improvements are available to the community, that the project will assist in the elimination of blight, and that the project is consistent with the Redevelopment Agency's Five Year Implementation Plan.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the

Redevelopment Agency, take the following actions:

- 1. Approve Agency funds totaling \$43,841 .OO for the cost of the construction change order for a portion of the Brommer Street improvements;
- 2. Approve the attached Resolution Accepting Unanticipated Revenue totaling \$35,000; and
- 3. Concur with and adopt the associated findings.
