DETENTION BUREAU FIXED ASSETS

Dear Members of the Board:

During the 1999/2000 Budget Hearings, your Board approved \$6,047 for the purchase of a replacement two person hydraulic maintenance lift for the Main Jail and \$2,250 for a replacement stove/oven at the Rountree facility. The General Services Department sent these items out to bid, it was found that it will cost a total of \$9,085 for a replacement two person hydraulic maintenance lift and \$3,452 for the replacement stove/oven.

The two person hydraulic maintenance lift in use at the Main Jail was manufactured in 1960 and is in need of replacement due to the age of the equipment and safety concerns regarding its use. The lift is used extensively for maintenance activities throughout the jail facility. The General Services Facilities Superinendent is in agreement with this replacement. The current stove/oven at the Rountree facility provides over 800 meals per day. The stove/oven that is currently in use was not designed for commercial use. It takes several hours to bring 10 gallons of liquid to a boil and is not an efficient unit for the amount of use it receives.

In order to proceed with the replacement of these two items as originally budgeted, the Sheriffs Office had identified \$7,240 in un-programmed interest from the State Law Enforcement Services Fund (SLESF), program years 96/97, 97/98 and 98/99. Additionally, the Detention Bureau has identified a need for a laptop computer to be used in staff training sessions. The use of a lap top in conjunction with Power Point Presentations will effectively and efficiently train larger numbers of staff in a classroom setting. It is anticipated that this lap top will cost \$3,000 and additional funding for this purchase is available from unused SLESF interest,



The total increase in fixed asset appropriations requested by the Detention Bureau is \$7,240. There will be no increase in the Net County Cost for these purchases.

It is, therefore, recommended that your Board:

- 1. APPROVE the attached resolution accepting and appropriating \$7,240 in unanticipated funds from interest in the State Supplemental Law Enforcement Services Fund;
- 2. AUTHORIZE an increase of \$3,038 to a new total amount of \$9,085 for the purchase of a two person hydraulic maintenance lift;
- 3. AUTHORIZE an increase of \$1,202 to a new total amount of \$3,452 for the purchase of a stove/oven at the Rountree Facility;
- 4. AUTHORIZE the purchase of a laptop computer in the amount of \$3,000.
