# AMENDMENT OF WELFARE-TO-WORK CONTRACTS

Dear Members of the Board:

On February 15, 2000, your Board considered a preliminary report on welfareto-work contracts and directed the Human Resources Agency (HRA) to return on this date with further recommendations. The purpose of this letter is to make recommendation regarding the term of contracts and additional funding to support welfare-to-work services provided by community-based organizations.

#### Background

As you are aware, the CareerWorks Division of the Human Resources Agency is subcontracting with the Community Action Board (CAB) to provide a work-related emergency payment fund for CalWORKs participants who become employed, and with Food & Nutrition Services to provide job training to CalWORKs participants. These projects, funded through the Governor's Discretionary 15% Welfare-to-Work Grant, have been successful in removing barriers to work which could not be handled in any other way. The contracts with these community-based agencies were originally planned to extend through June 30, 2000, however, due to grant savings, it is now possible to extend them through September 30, 2000.

#### **Contract Amendments**

Given the success of the Community Action Board Work-Related Emergency Payments Fund as a job retention strategy, an increase in the CAB contract is required to ensure that services continue through the term of the grant (September 30, 2000). The proposed contract amendment with CAB utilizes savings of \$148,500 in the Welfare-to-Work grant, and \$45,707 in revenue

\$194,207 to contract #91776, retroactive to January 1, 2000, and an extension of the agreement term through September 30, 2000. A contract amendment has been developed and signed by the contractor, and is on file with the Clerk of the Board.

In addition, due to delays in initial startup, the Human Resources Agency is recommending a amendment to contract #91774 with Food & Nutrition Services for the job training program known as the Connections Shuttle to extend the term of the agreement through September 30, 2000, at no additional cost. A contract amendment has been developed and signed by the contractor, and is on file with the Clerk of the Board.

A transfer of funds will be necessary to accomplish these changes, and an AUD 74 is attached for your approval. Because federal and state dollars fund both contracts in full, the recommended amendments represent no cost to the County.

IT IS THEREFORE RECOMMENDED that your Board:

- 1. Approve a contract amendment augmenting the Community Action Board contract #91776 by \$194,207, retroactive to January 1, 2000, for a total contract not to exceed \$342,311, and extending the term of the agreement through September 30, 2000;
- 2. Approve a contract amendment with Food & Nutrition Services to extend the term of agreement #91774 through September 30, 2000;
- 3. Approve the necessary transfer of funds, and authorize the Human Resources Agency Administrator to sign the contract amendments on behalf of the County.
