#### Background:

Dr. George Wolfe MD retired in October of 1999 as County Health **Officer**. Since then County Personnet has worked with the Health Services Agency and the County Administrative **Officer** to coordinate a national recruitment to fill this vital position. This recruitment resulted in 16 qualified candidates for the position. **After** extensive interviews, reference checks, and review of credentials and qualifications, the Health Services Agency recommends appointment of Dr. David R. McNutt as County Health Officer.

Dr. McNutt brings 27 years in health care and preventive medicine to this position, He has extensive experience in public health and primary care and has served as health officer in 3 county positions in other states. He has oversee complex health systems and programs at the federal, state, and county levels. He has overseen public health, behavioral health, and emergency service programs. He has medical specialties in preventive medicine, internal medicine, and occupational medicine.

We are fortunate to have someone of Dr. **McNutt's** caliber available to serve in our local community. With Board approval he will begin work in April part time and become full time on May 1<sup>st</sup>, 2000. In order to comply with State law, Dr. Wolfe must be designated as Health Officer by your Board, as indicated in the attached resolution.

It is THEREFORE RECOMMENDED that your Board:

1. Approve and adopt the attached resolution appointing the statutory responsibilities of the County Health **Officer** to David R. **McNutt**, MD pursuant to Section 45 1 of the Health and Safety Code.
