Re: Rio Highlands Subdivision: Request for Release of Securities

Dear Members of the Board:

On August 19, 1997, the Board of Supervisors approved the final map for the Rio Highlands Subdivision. The Public Works Department inspected the improvements and found them complete. The Board has yet to accept the improvements as complete due to concerns with the integrity of a retaining wall, wrought iron fence and landscaping.

The subdivider has now submitted a formal request pursuant to Code of Civil Procedure sections 996.020 and 996.030 to the Board for the release of the Faithful Performance Securities. The following options are available for the Board's consideration:

- (1) Release fifty percent of the Faithful Performance Security which amounts to \$759,000.00, plus the Tax Security of \$30,000.00, plus the Monumentation Security of \$11,625.00 for a total of \$800,625.00, while retaining the Labor and Material Security in the amount of \$759,000.00 and the other fifty percent of the Faithful Performance Security for the Guarantee, Warranty and Maintenance Security in the amount of \$759,000.00 for the periods prescribed by law (i.e. ninety days and one year respectively, from the date of acceptance of the improvements);
- (2) Release the amounts discussed in (1) above reduced by an amount sufficient to address the concerns regarding the retaining wall (\$96,800.00), the fence (\$9,600.00) and

irrigated landscaping in the area of the fence maintained for a six month period (\$30,000.00); or

(3) deny the subdivider's request.

The issues of concern to the Board have not been addressed by the subdivider.

IT IS THEREFORE RECOMMENDED that your Board take the following actions:

- 1. Accept the site improvements for Rio Highlands, Tract 1343, as complete in accordance with previously approved plans;
- 2. Adopt the attached resolution accepting the right of way areas designated Parcels B and C of the Rio Highlands Subdivision Map into the County maintained system;
- 3. Direct the Clerk of the Board to release the Tax Security of \$30,000.00, plus the Monumentation Security of \$11,625.00, plus release \$622,600.00 of the Faithful Performance Security, while retaining the balance of the Faithful Performance Security to provide for the Guarantee, Warranty and Maintenance of Work Security in the amount of \$759,000.00, and in addition retaining \$96,800.00 until the issue regarding the integrity of the retaining wall is resolved to the Board's satisfaction and \$39,600.00 until the issue of the fence constructed on top of the retaining wall and related landscaping in the area of the fence is resolved to the Board's satisfaction;
- 4. If, at the end of three months, a search of the records by the Auditor-Controller's office reveals no posted liens against the project, authorize the Clerk of the Board to release the Labor and Materials Security; and
  - 5. If there are no problems with the improvements at the end of twelve

months, authorize the Clerk of the Board to release the Guarantee, Warranty and Maintenance of Work Security.
