Members of the Board:

The subject project was completed on March 1, 2000. The Contractor was B & R Roofing Company. The original bid amount was \$514,000. Change orders were processed in the amount of \$4,479 to provide 1200 stainless steel spikes and the installation of four new base isolators, redwood around 3 curb penetrations, 22 gallon stainless steel closure, and a 2001 term bar in place of Sarnafil Sarnareglet. Total construction cost was \$518,479.

It is therefore RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed; and
- 2) Approve the final cost of \$518,479; and
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the office of the County Recorder, a copy of which is attached.
