Re: RECOMMENDATION OF AWARD FOR SIMPKINS CENTER-ACOUSTICAL

UPGRADE, 99C 1 - 008

Members of the Board:

At the March 7, 2000 Board meeting, bids were received for the Simpkins Center-Acoustical Upgrade project. Your Board directed the General Services Department to review bids and return on or before March 21, 2000 with a recommendation for award.

As directed, bids received have been reviewed and we believe that the lowest bidder, Rehak Construction with a bid of \$42,600 can accomplish the work to the County's satisfaction.

Sufficient funds are available in the Plant, Index 192 166, Sub Object 66 10, including a ten (IO) per cent contingency. As indicated to your Board previously, the Redevelopment Agency will be reimbursing the Parks Department for the cost of this project.

It is therefore RECOMMENDED that your Board:

- 1. Award a contract to Rehak Construction in the amount of \$42,600 for the Simpkins Center-Acoustical Upgrade project; and
- 2. Authorize the General Services Director to notify the contractor and sign the contract agreements and associated documents on behalf of your Board; and

3. Authorize the Director of Parks, Open Space & Cultural Services to approve change orders and appropriate \$4,260 in addition to the contract amount to cover change order expenditures, as required.
