On January 25, 2000, your Board received a status report on impervious area fees for new construction (copy attached) and directed staff to report back at this time.

As indicated in the last report, City of Watsonville staff have indicated a willingness to take the concept of impervious area fees to the City Council for consideration. In response to the City's request, Zone 7 staff have provided sample ordinances (those establishing Zone 5) which include provisions for collecting such fees within both an incorporated city (the City of Capitola) and the unincorporated county. Zone 7 staff propose to be available at the City Council meeting to respond to questions. Members of the Board:

On September 21, 1999, your Board considered a report (copy attached) on Impervious Area Fees for new construction and directed staff to report back at this time.

Since the last report, County staff has met with City of Watsonville staff to discuss impervious area fees as a method to augment current Zone 7 drainage revenues to better address local match requirements and related costs of the planned Army Corps Pajaro River Levee Reconstruction Project. City staff asked that other options such as formation of a Storm Water Utility be reviewed as well. In response, Zone 7 staff fully reviewed possible options with County Counsel. Counsel stated that formation of a Storm Water Utility and the levying of fees, assessments, or charges would be subject to the provisions of Proposition 218 and its notice and ballot procedures. Proposition 218 does not apply to the imposition of fees or charges imposed as a condition of property development (Article XIII D, section 1 (b)1). Development fees such as impervious surface fees specific to parcel development are akin to park dedication fees, transportation fees, roadside improvement fees, roadway improvement fees, and other development fees.

Subsequent discussions with City staff have indicated a willingness to take the concept of impervious area fees to the City Council for consideration. It is anticipated that the matter will be considered by the Council within the coming month. If the Council is supportive of establishing these fees within the city, it is proposed that the matter also be presented to the Board of Supervisors for consideration within the unincorporated county within Zone 7. Impervious area fees in other County drainage districts are currently \$0.65 per square foot of new impervious area, and similar charges are recommended within Zone 7. As previously indicated, it is estimated that over \$250,000 per year could be generated through impervious area fees to help offset the currently estimated \$10 to \$50 million local match costs of the Pajaro River Levee Reconstruction Project.

As discussed in a separate report on today's agenda, attempts were recently made to develop a Memorandum of Understanding (MOU) with neighboring counties which would have included establishing impervious area fees within the entire Pajaro River Basin. Unfortunately, these efforts to adopt an MOU were unsuccessful. While staff will continue to work with local elected officials to pursue assistance with local match funding from neighboring counties, as well as state and federal sources, staff believes it is important to continue to implement reasonable local revenue options at this time.

It is therefore recommended that your Board direct Zone 7 staff to work with City staff to place the matter of impervious area fees before the City Council and subsequently before the Board of Supervisors for consideration, and to report back at your next meeting on March 21, 2000.

Members of the Board:

On January 25, 2000, a status report on the Pajaro River Four-County Basin Study (Exhibit "A") was submitted to the Santa Cruz County Flood Control and Water Conservation District Zone 7. Your Board directed that another status report be presented today.

As indicated in the last report, a meeting of the four counties and four water/flood control agencies was held on January 20, 2000. The principal outcome of the meeting was agreement by county and agency representatives to continue formal meetings as required under Assembly Bill 807 to address the many Pajaro River watershed flood control issues. The representatives further agreed that in order to coordinate these meetings, as well as to provide necessary legal notice, agendas, minutes, draft reports, legal advice, and related administrative support, it was preferable to contract for these services with a neutral contractor or agency, such as the Association of Monterey Bay Area Governments (AMBAG). Staff from the eight agencies have coordinated to develop a scope of work for these administrative services (Exhibit "B") and will present the scope together with a recommended contractor to the Pajaro River Watershed Flood Protection Authority (PRW'FPA) representatives at its next meeting, which will be scheduled in the near future. The Executive Director of AMBAG has reviewed the scope of work and has indicated an interest on the part of that agency in performing this role, subject to provision of necessary funds and consensus approval from all participating agency representatives that AMBAG is the preferred agency to provide administrative services.

As your Board is aware, the recently approved Proposition 13 (the State Water Bond) will provide significant funding for Pajaro River watershed studies. It is hoped that a portion of these **funds** will become available to support the activities of the PRWFPA. However, even with approval of the bond, funds will likely not be available for approximately one year. The PRWFPA Board is interested in expeditiously moving ahead with interagency coordination efforts, as well as beginning scoping of a Pajaro River Watershed Study to address the significant flooding and land use impact concerns currently facing the four counties. Consequently, in order to begin this work, each agency agreed to pursue authorization for a \$6,000 contribution toward administration of this joint effort. Adequate funds for this purpose are available in Zone 7 Army Corps Flood Control Project **funds**. A similar request was approved by the County of Santa Cruz Board of Supervisors on February 15, 2000.

It is therefore recommended that your Board approve the attached AUD-74, transferring **funds** from Army Corps and Flood Control Projects and authorize a contribution of \$6,000 toward PRWFPA administrative services as described in this report.

Members of the Board:

On September 21, 1999, your Board received the last status report on efforts to work cooperatively with Santa Clara, San Benito, and Monterey Counties to address flood control problems in the Pajaro River Basin. Your Board directed that another status report be presented today.

Since the last Zone 7 meeting, reports continued to be presented to the Santa Cruz County Board of Supervisors, with copies to your Board. The most recent report was presented on December 7, 1999 (Attachment 1). As indicated in that report, efforts to reach an agreement on a Memorandum of Understanding (MOU) were unfortunately unsuccessful. Letters were sent (Attachment 2) thanking the other jurisdictions for participating in the MOU process and suggesting another meeting to initiate cooperative efforts under the provisions of Assembly Bill 807, which is now law: Santa Clara County Supervisor Don Cage has agreed to host such a meeting on January 20, 2000, as indicated in a letter from Supervisor Tony Campos (Attachment 3).

It is therefore recommended that the Board of Directors take the following action:

- Appoint the Zone 7 Chairperson or their designee as the official Zone 7 liaison to 1. the ongoing four-county meeting of elected representatives.

# SCOPE OF WORK ADMINISTRATIVE SERVICES CONTRACT PAJARO RIVER WATERSHED FLOOD PREVENTION

The Counties of Monterey, San Benito, Santa Clara and Santa Cruz, together with the Santa Clara Valley Water District, Santa Cruz County Flood Control and Water Conservation District Zone 7, the San Benito County Water District and the Monterey County Water Resources Agency have all designated representatives for the purpose of developing a Pajaro River Watershed Flood Prevention Authority (PRWFPA). These agencies are seeking the services of a private firm or interested local regional government to provide certain administrative functions for the eight participating agencies as described below.

#### Necessary Services and Skills:

- 1. Ability to maintain a neutral position relative to the eight agencies and their respective issues and perspectives.
- 2. Organize, schedule and notice meetings, workshops and hearings of the designated representatives.
- 3. Organize and schedule meetings of the staff of the eight participating agencies,
- 4. Prepare/distribute agendas, take minutes, activate/set up public address systems, record proceedings and carry out similar work related to the meetings.
- 5. Prepare basic reports to and correspondence from the combined agencies based on input from the staff of the eight participating agencies.
- 6. Insure that all participating agencies are kept up to date and informed (through the use of mail, e-mail and fax) of proposed agenda items, correspondence and other information related to the joint efforts of the eight participating agencies.
- 7. Process correspondence, maintain files and carry out related work.
- 8. Provide a range of staff support, including clerical and administrative to insure the most effective, efficient and fiscally responsible staffing level for the respective tasks.
- 9. Contractor should have experience in contract administration and working with government agencies.
- 10. Ability to access to legal counsel in matters of flood prevention, land use, procedural government and related law through the contractor is very desirable.
- 11. Contractor experience in civil engineering, flood prevention and environmental matters is desirable.

Currently it is estimated that the designated representatives of the eight participating agencies will hold monthly or bimonthly two to three hour meetings. It is estimated that participating agency staff will be required to hold two three hour meetings per month. The frequency of meetings may vary significantly depending on the issues and work program being undertaken at any given time. The Contractor needs to have the ability to provide varying levels of staff support to meet the needs of the eight participating agencies. Meeting locations will rotate between the various agency jurisdictions. The meetings of the designated representatives of the eight participating agencies will be conducted in accordance with the provisions of the "Brown Act"; they will need to be noticed accordingly. The duties and structure of the PRWFPA are described in Chapter 963, Statutes of 1999, Pajaro River Watershed Flood Prevention Authority Act.

This report containing the Assessor's parcel number, use code, the owner's name and the amount of the assessment will be available on or before May 5, 2000. As in previous years, the rate report must be approved by your Board and forwarded to the Auditor-Controller by August 10, 2000.

SUBJECT: PAJARO RIVER LEVEE SYSTEM RECONSTRUCTION PROJECT

Members of the Board:

On January 25, 2000, your Board received the last status report (Attachment 1) on efforts to move forward with the Army Corps' flood control project for Salsipuedes Creek, Corralitos Creek and the Pajaro River. Your Board adopted the staff recommendations and directed a further status report on this date.

#### PROJECT STATUS

Since the last report, County staff has continued to meet with Army Corps representatives on a regular basis. At the last meeting on February 10, 2000, the Army Corps provided a detailed draft preliminary project schedule calling for construction to begin in late 2004. While this is a later date than had been proposed in meetings with Congress Member Sam Farr and Assistant Secretary of the Army Dr. Joseph Westphal, the Army Corps' San Francisco District indicates that given the necessary engineering, environmental review, contract development, bidding, and contract award time lines, this represents the most aggressive schedule possible.

This preliminary schedule calls for geotechnical analysis of the existing levee system to begin this month to assess levee integrity. This analysis will provide an important basis for subsequent design work. The Army Corps has indicated that preparation of work orders to accomplish the geotechnical analysis under existing contracts is proceeding on schedule.

The Army Corps has also indicated that additional analysis has been performed to assess whether the State Highway 129 and 152 bridges will need to be retrofitted or replaced in conjunction with the proposed flood control work. This is an important local cost issue since bridge replacement costs are considered a local responsibility under Army Corps cost sharing regulations. Based on the current preliminary design concepts, the Army Corps states that both bridges have been determined to be adequate from the perspective of "scour." This means that the projected

design flows are not expected to undermine the bridge footings or abutments. Analysis of bridge buoyancy was also carried out. The Highway 129 bridge was determined to be adequate, while the 152 bridge will require additional analysis. If the 152 bridge is too buoyant, retrofitting to prevent the bridge deck from floating downstream during high flows will be required. The Army Corps will pursue this additional analysis.

Zone 7 staff will continue to work closely with the Army Corps to facilitate keeping the project on schedule. Our next meeting with the Army Corps is scheduled for March 24, 2000.

#### STEERING COMMITTEE

As indicated in our last report, and as directed by your Board, staff has requested that the Army Corps, the City of Watsonville, the Farm Bureau, Wetlands Watch, State Fish and Game, the Pajaro Valley Water Management Agency and the County of Santa Cruz provide representatives to a Design Review Steering Committee for the project. Since the last report, staff has also invited the Monterey County Water Resources Agency to participate, as directed by your Board. Most agencies have now responded with appointments and **staff is** following up with those who have not responded in order to allow a first meeting to orient the committee to be held in April 2000.

As directed, staff has also contacted HDR Engineering, our consultants on this project, to initiate assessment of the proposed Army Corps project. HDR will develop some initial proposals for consideration by the Steering Committee of alternate methods to address the various design issues previously raised by your Board. This will assist in efforts to focus the Army Corps' analysis on a project approach most likely to be supported by our community and one which will not only maximize the level of flood protection, but will also provide enhancements to recreational opportunities, aesthetics and environmental quality, while minimizing long term maintenance costs, law enforcement difficulties and adverse visual impacts.

#### STATUS OF APPROPRIATIONS

As indicated in our last status report, adequate appropriations for the current fiscal year appear to be available. The initial appropriations secured by Congress Member Sam Farr, together with the anticipated reprogramming of other Army Corps appropriations, are expected to achieve the \$1.2 million necessary to allow geotechnical and design work to proceed in an unrestricted manner through federal fiscal year 2000.

Unfortunately, in the 2001 fiscal year the San Francisco District of the Army Corps has indicated that they have the capability to utilize \$1.8 to \$1.9 million for continuing design work, while the President's budget only contains proposed appropriations of \$600,000. Unless appropriations in the 2001 final budget are augmented to this level, delays in the design process and ultimately the project construction schedule will result. Consequently, staff is again working closely with Congress Member Sam Farr and his staff to seek the necessary budget augmentation. Letters requesting his support, as well as the support of our Senate representatives have been sent (Attachment 2).

Zone 7 staff and our Washington, D.C. advocate will continue to follow the federal budget process closely to provide necessary support to our federal representatives to maximize opportunities for successfully incorporating the augmentation into the final federal budget. The first critical step toward achieving this goal was to receive the support of the California State Water

Commission for the augmentation. Each year the Commission compiles budget requests for all Army Corps projects throughout the state and makes budgetary recommendations to the Senate and Congressional Appropriations Committees. The Commission's recommendations are very influential. Staff wrote to the Commission (Attachment 3), coordinated with the Army Corps and Commission staff, as well as presented testimony at the Commission hearing on March 3, 2000. As a result, the Commission has indicated it will include the requested augmentation in its recommendations.

Finally, as indicated in previous reports, significant steps have also been taken toward the overall project construction financing. However, much work remains to be done in this area, particularly with regard to local match funding. Staff will continue to work with our elected representatives in this critical ongoing effort to address local cost match requirements. Ultimately, it is anticipated that it will take a combination of local funding mechanisms (such as the impervious area fees discussed in a separate report on today's agenda), assistance from other Pajaro River Basin counties and various grant revenues, together with additional state and federal monies, to fully address local match requirements.

It is therefore recommended that your Board take the following action:

- 1. Accept and file this report.
- 2. Direct staff to continue working closely with our federal legislators to insure that necessary appropriations are included in the 2001 budget to allow the design of the Pajaro River Levee System Reconstruction Project to proceed without delay.
- 3. Direct staff to continue working with our local, state and federal representatives to address local cost match funding requirements of the project.
- 4. Direct that a further status report be presented at your Board's next meeting on June 20, 2000.

SUBJECT: PAJARO RIVER LEVEE SYSTEM RECONSTRUCTION PROJECT

Members of the Board:

On September 21, 1999, your Board received a status report (Exhibit "A") on efforts to move forward with Army Corps flood control projects for Salsipuedes Creek, Corralitos Creek, and the Pajaro River. Your Board adopted the staff recommendations, made one additional direction as discussed below, and directed a further status report on this date.

#### **PROJECT STATUS**

As directed by your Board in conjunction with the last status report, staff has requested that the Pajaro River Mainstem Project be combined with the Salsipuedes/Corralitos Creek Project into one Pajaro River Levee Reconstruction Project to fully address the flood control needs of the city of Watsonville, town of Pajaro, and the surrounding areas. A copy of related correspondence is attached as Exhibit "B." The Army Corps is expected to expand design studies to include the mainstem over the coming months. This current design phase, including a federal Environmental Impact Statement is estimated to continue into federal fiscal year 2002. Final design documents will then be completed with the goal of beginning first phase construction in late 2003. This is an aggressive schedule with many points of potential delay; however, staff will continue to work closely with the Army Corps and elected officials to expedite the process. Our next meeting with the Army Corps is on January 19, 2000, in San Francisco.

In our last report, it was indicated that it may be necessary for Zone 7 to contract for engineering studies to assess needed bridge modifications, which might be required in conjunction with the project. Further discussions with the Army Corps have concluded that this assessment continues to be an Army Corps responsibility. Consequently, no Request for Proposals has been initiated for this purpose. This successful interpretation represents a significant cost savings for Zone 7.

#### STEERING COMMITTEE

Your Board previously directed that a Design Review Steering Committee be established to assist staff in coordinating with the Army Corps toward the goal of identifying a preferred flood control project alternative that is cost effective and includes design considerations necessary for broad-based community support. Letters requesting appointments to the committee from the seven agencies named by your Board have also been transmitted (Exhibit "C"). These agencies include the Army Corps, the City of Watsonville, the Farm Bureau, Wetlands Watch, State Fish and Game, the Pajaro Valley Water Management Agency, and the County of Santa Cruz. A request has also been received from the Monterey County Water Resources Agency to participate. They were originally omitted because the Salsipuedes/Corralitos Creek Project was wholly within Santa Cruz County. With the inclusion of the Pajaro River Mainstem Project, staff recommends that your Board authorize inclusion of a representative from Monterey County.

One of the first orders of business for the steering committee will be to identify and assess various conceptual project alternatives. This will assist in efforts to focus the Army Corps' analysis on project approaches most likely to be supported by our community. In order to expeditiously develop initial designs and drawings to conceptualize such project alternatives, staff believes it is best if this work is carried out by a private engineering firm under contract to Zone 7. HDR Engineering, our consultant, is already effectively advocating on behalf of our project and has expressed interest in conducting this work. It is recommended that they be asked to submit a proposal.

#### STATUS OF APPROPRIATIONS

As indicated in our last report, Congressmember Sam Farr had successfully included a total of \$700,000 for Pajaro River flood control design studies in the federal Energy and Water Appropriations Bill. The final bill, as signed into law, ultimately included a total of \$450,000. Based on recent discussions with San Francisco District Army Corps representatives, it appears that these approved funds can be augmented with sufficient reappropriation within the Army Corps budget to allow design work on the Pajaro River Levee Reconstruction Project to expeditiously continue in the current federal fiscal year with no funding-induced delays.

In addition to the ongoing design work, the Army Corps has indicated that conducting a complete geotechnical analysis of the existing levee system is a top priority in allowing the project design to proceed. This geotechnical analysis would assess the integrity and any needed remediation to the existing levees, which might be required in conjunction with the ultimate reconstruction project. It is estimated that this analysis will cost approximately \$1.1 million.

Recent discussions with Army Corps representatives indicate that there is a current open contract for geotechnical work, which has sufficient appropriations to conduct the necessary work. If use of this existing Sacramento District contract is approved by the Army Corps' South Pacific Division, geotechnical work could begin this spring. If the geotechnical analysis is carried out, it would represent a very significant step forward in the design process and a highly commendable demonstration of the Army Corps' commitment to the Pajaro River Levee Reconstruction Project. Staff, together with our Sacramento-based advocates, is continuing to work closely with the Army Corps to speed successful completion of this work.



Finally, as indicated in a report to the Board of Supervisors on November 16, 1999, (Exhibit D) significant steps have also been taken toward the overall project construction financing; however, much work remains to be done in this area, particularly with regard to local match funding. Staff will continue to work with our elected representatives in this critical ongoing effort to address local cost match requirements. Ultimately, it is anticipated that it will take a combination of local funding mechanisms (such as the impervious area fees proposed in a separate report on today's agenda), assistance from other Pajaro River Basin counties and various grant revenues, together with additional state and federal monies, to fully address local match requirements.

It is therefore recommended that your Board take the following action:

- 1. Accept and file this report.
- 2. Direct **staff** to ask Monterey County to name a representative to the Pajaro River Levee Reconstruction Project Design Review Steering Committee.
- 3. Direct staff to seek a proposal for developing conceptual project design alternatives as discussed in this report and authorize the District Engineer to enter into a contract or contract amendment for a not-to-exceed amount of up to \$50,000 from the Zone 7 Corps of Engineers Salsipuedes Creek Local Share budget line item.
- 4. Direct that a further status report on the Pajaro River Levee Reconstruction Project be presented at your next meeting on March 21, 2000.
