REQUEST TO ADVERTISE KITCHEN FLOORING-MEDIUM SECURITY JAIL #99C 1-005

Members of the Board:

As part of the 1999/2000 Plant Budget, your Board allocated funds to provide for a licensed contractor to provide labor and materials for the removal of existing linoleum, surface preparation and installation of approximately 2,750 sq. ft. of new epoxy floor coating at the Watsonville Detention Facility. Plans and specifications have been prepared by the Department of General Services. These items and associated documents related to the project must be approved by your Board prior to solicitation of written proposals. Funds are available in Budget Index 333 100 , Sub-Object 3405. The cost of the project is estimated at \$13,500.

It is therefore RECOMMENDED that your Board take the following actions:

1. Approve plans and specifications on file with the Clerk of the Board for the Kitchen Flooring - Medium Security Jail #99C 1-005;




