#### Approve Contract Amendment for Welfare-to-Work Transportation

Dear Members of the Board:

On April 11, 2000, your Board accepted and appropriated \$100,000 in unanticipated revenue from a Job Access/Reverse Commute (JARC) grant and directed the Human Resources Agency (HRA) to negotiate contracts and return to your Board for contract approval. The purpose of this letter is to amend an existing contract with Food & Nutrition Services to implement part of the Job Access/Reverse Commute grant.

As you know, Food & Nutrition Services operates the Connections Shuttle as a training activity for CalWORKs participants, who earn their Class B drivers' licenses and learn dispatching skills, while providing shuttle services to CalWORKs families who cannot use the bus for all or part of their routes. A contract amendment is proposed to increase the contract with Food & Nutrition by \$100,000 for the purpose of purchasing four vans for the Connections Shuttle, bringing the total contract amount to \$412,718. The vans will need to be purchased prior to the end of the fiscal year, as specified in the JARC grant. The attached contract amendment has been approved by the contractor, County Counsel and Risk Management.

In addition, the Human Resources Agency plans to return to your Board prior to June 30 for approval of two additional contracts for the other services funded by the JARC grant.

IT IS THEREFORE RECOMMENDED that your Board approve a contract amendment with Food & Nutrition Services, increasing contract # 9 1774 by \$100,000 to \$412,718, and authorize the Human Resources Agency Administrator to sign the amendment on behalf of the County.

### **Contract Amendment #2**

This document amends Contract #9 1774 between the County of Santa Cruz Human Resources Agency and Food & Nutrition Services for the provision of the Connections Shuttle, effective May 2, 2000.

The agreement shall be amended as follows:

The amount of the agreement shall be increased by \$100,000 for the purchase of four shuttle vans by 6/30/2000, funded by the Job Access/Reverse Commute grant.

All other provisions of the agreement remain the same.
