**SUBJECT: 30TH, 32ND, AND 33RD AVENUE STORM DRAIN, SANITARY SEWER,
AND SIDEWALK IMPROVEMENTS**

Members of the Board:

Included in the 1999/2000 Redevelopment Agency budget are funds for the construction of the subject storm drain and sidewalk improvements and a portion of the street overlay. On May 4, 2000, the Santa Cruz County Sanitation District is scheduled to approve funds for the sanitary sewer improvements and the balance of the street overlay.

The plans, specifications, and estimate have been completed for the subject project, and are presented here for your consideration and approval. The total engineer's estimate for this project is \$1,375,000 not including contingencies and administration. Sufficient funds are available for this project.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
2. Set bid opening for 10:45 a.m on May 23, 2000.




Bids are required for the entire work.
