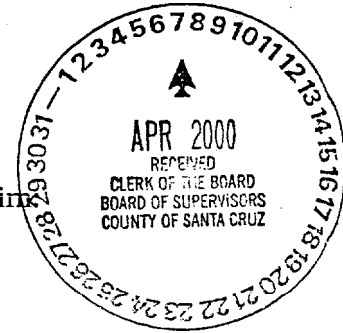

DATE, PLACE AND OTHER CIRCUMSTANCES OF THE OCCURRENCE OR INCIDENT WHICH GIVE RISE TO THE CLAIM ASSERTED:

On October 13, 1999 Sergeant James Hart of the Santa Cruz Sheriff's Office was present at the home of Jeff Rodriqs at 662 Sunset Drive in Capitola, California. Jeff Rodriqs suffers from Multiple Sclerosis and has been diagnosed with this condition for approximately ten years. Mr. Rodriqs has been treated by Dr. Schoenfeld for this illness and has recommended that Mr. Rodriqs use marijuana pursuant to Proposition 2 15. On the 13th, Sergeant Hart was advised by Mr. Rodriqs of his medical condition and was shown the recommendation by Dr. Schoenfeld. Sergeant Hart declared to Mr. Rodriqs that, "Dr. Schoenfeld is a quack". Thereafter, at Sergeant Hart's direction, Sergeant Hart and Capitola Police officers confiscated Mr. Rodriqs' medical marijuana.
