Motor Vehicle Emission Reduction Grant Applications

Dear Members of the Board:

The Monterey Bay Unified Air Pollution Control District (MBUAPCD) administers the AB 2766 Motor Vehicle Emission Reduction Grant Program. The program provides funds for projects which reduce air pollution from motor vehicles and related planning, monitoring, enforcement and technical studies to implement the California Clean Air Act. The amount available will be determined by the District Board, but will exceed one million dollars. Public agencies in Santa Cruz, Monterey, and San Benito Counties are eligible to apply. The District is seeking project applications which would reduce motor vehicle emissions or would build, operate or demonstrate emission-reducing infrastructure. Projects are scored by cost effectiveness, status as an adopted Transportation Control Measure, total project cost relative to request, and reduction of vehicle miles traveled. Two County departments have prepared applications for your Board's approval.

The General Services Department is applying for \$5,500 to fund the purchase of four electric bicycles to be used on a daily basis by County employees traveling between facilities. The electric bicycles will be available to employees for both business and personal trips. The department estimates that the purchase of the electric bicycles will eliminate a total of 800 internal combustion vehicle trips per year. The General Services application is attached.

The Department of Public Works is sponsoring an application from Ecology Action to partially fund the Santa Cruz County Electric Bike Commuter Incentive Program. The purpose of this program is to encourage the regular use of cost-effective, appropriate electric transportation technology to reduce single occupancy auto trips, traffic congestion, traffic volumes, and air pollution. Ecology Action is applying for \$150,000. These funds will be used to offer a financial subsidy/rebate to County residents for the purchase of electric bikes for use in commuting, to provide safety accessories (helmets, lights, etc), and to install solar charging/storage facilities throughout the area. 25% of the funds would be used for staff time. Additional information on the program is attached.

Both these applications will make a significant difference in the air quality of our community. It is the recommendation of this office that your Board approve both these applications.

IT IS THEREFORE RECOMMENDED THAT YOUR BOARD adopt the resolution approving the submission of applications from the General Services Department and the Department of Public Works to the Monterey Bay Unified Air Pollution Control District for the Motor Vehicle Emission Reduction Grant Program.

WHEREAS, the Monterey Bay Unified Air Pollution Control District is the administrating agency of the AB 2766 Grant Program for mobile source emission reduction projects; and

WHEREAS, Santa Cruz County is proposing to purchase four electric bicycles for County employee usage to encourage the reduction in motor vehicle internal combustion trips; and

WHEREAS, Santa Cruz County is proposing to sponsor the Electric Bike Commuter Incentive Program that would reduce peak hour congestion, improve air quality, and improve bicyclist safety.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Santa Cruz:

- 1. Approve the filing of grant applications to the Monterey Bay Unified Air Pollution Control District to seek AB 2766 grant funding to purchase four electric bicycles for County employees and pursue funding for the Electric Bike Commuter Incentive Program.
- 2. Appoint Roy Holmberg, Director of General Services, and the General Services Department, administrating agency applicant to execute and submit all documents including, but not limited to: applications, agreements, amendments, payment requests, etc., which may be necessary to purchase the four electric bicycles.
- 3. Appoint John A. Fantham, Director of Public Works, and the Department of Public Works, administrating agency applicant to act as a project sponsor for Ecology Action, and to execute and submit all documents including, but not limited to: applications, agreements, amendments, payment requests, etc., which may be necessary to pursue funding for the Electric Bike Commuter Incentive Program.

Attached is a Grant Application from the County of Santa Cruz seeking \$5,500 in FY 2000/2001 AB 2766 Motor Vehicle Emissions Reduction Grant Program funds. for the purchase of four electric bicycles to be used on a daily basis by County employees traveling between facilities.

The County has long supported measures to remove vehicles from the roads. and the electric bicycles proposed under this project are expected to do just that. The frequency of business related travel, the proximity of many of the destinations, very limited parking options in the downtown area and at County facilities, and the number of mild weather days per year, all make these bicycles a very attractive alternative to travel by car, truck, or utility vehicle and weigh heavily in favor of a successful project.

In making the electric bicycles available for the numerous daily trips between the County Government Center on Ocean Street and our Health Services/Human Resources Agency campus on Emeline Street. we anticipate the elimination of at least 800 internal combustion vehicle trips per year. Additionally, the numerous business trips made by County employees to the City government offices and the downtown commercial district are well suited to this kind of transportation. And, as is our policy with the existing fleet of employee-use conventional bicycles, if available these electric bikes may also be used during lunch periods and other time-off throughout the day for banking and personal errands, displacing further internal combustion vehicle trips.

Nor do we anticipate that the addition of these bicycles to our existing fleet will reduce current usage of conventional bicycles. Rather, we think it will provide a stigma-free alternative and an incentive for participation by older employees and those with limiting physical conditions or disabilities.

This project should be a very good match with the objectives of the AB 2766 program. We ask that you accept and review our application, and we thank the District for funding consideration.

ATTACHMENT 1 A - PROJECT NARRATIVE FY 2000-2001 AB 2766 Motor Vehicle Emission Reduction Grant Program

Project Title	Inter-facility Electric Bicycle Fleet
Grantee Agency	County of Santa Cruz

This project will provide four (4) electric bicycles for use by County employees when conducting business related travel between facilities, primarily between the County Government Center and the County Emeline Street campus.

There are approximately 1000 employees at the multi-story Government Center and Courts facilities on Ocean Street, and another group of approximately 1000 employees working 1.5 miles away at the 12-building Emeline Street campus. Inter-facility trips for meetings and routine business activity are necessary numerous times each day. While some of these trips are completed using bicycle? from the fleet of County owned bikes available for such purposes, most are made via privately owned or County fleet internal-combustion vehicle. The electric bicycles proposed for this project will provide an option for an expanded range of employees, including many that are reluctant or unable to take advantage of currently available alternatives to making these trips by car or truck. Offering a choice that is accessible to older employees and those with disabilities or limiting physical conditions will insure that overall participation remains high. With the mild weather we enjoy in Santa Cruz County, the nature and frequency of travel between these two sites, and the support of County employees for clean air and traffic mitigation programs, we anticipate that at least 800 car and truck trips will be eliminated per year.

The conduct of County business also includes occasional travel to Santa Cruz City Government offices and, somewhat less frequently, to the downtown business community. These destinations are within 1 mile of the County Government Center and within 2.5 miles of the Emeline campus. We believe that at least 100 of these trips per year would be completed via electric bicycle if available.

When not otherwise committed, the electric bicycles will also be available for employee use to complete banking and personal errands during lunch periods and other workday off-hours. The vast majority of these trips are likely to be within a similar 1 to 3 mile one-way proximity.- It is estimated that such use would eliminate at least 400 car or truck trips per year.

While the estimated annual mileage of the electric bicycles is relatively modest, at 3000 to 4000 total, the car and truck trips eliminated are quite significant. These would otherwise be cold-start short distance vehicle trips, the type most damaging to the environment. With a 1 mile cold-start car trip generally considered to yield 70% of the hydrocarbon pollution of a 10 mile trip, these are exactly the trips we want to replace.

As a new program the mileage figures and trips eliminated are estimates only, based on current usage of the County Bicycle Fleet and participation in various trip reduction promotions staged on a regular basis. County employees have historically supported environmental projects and have demonstrated a willingness to utilize alternatives to cars when provided with a viable alternative. Our existing bicycle fleet receives substantial usage, and augmenting it with the proposed electric bikes will increase the group *able* to participate. The fact that electric bicycles are fun to ride and that they allow participation by those with physical limitations suggests that eventual participation will exceed the estimates we have utilized.

This request for AB 2766 Grant Program funding allows \$1200 each for the four electric bicycles and a total of \$700 for safety equipment and accessories to enable and encourage business use, such as racks and baskets. The four bicycles will include at least two models with step-through frames. Should the electric bicycles ultimately selected be priced above the \$1200 figure the balance w-ill be provided from County appropriations, and all maintenance and operating costs will be provided by the County. Project Promotion and Grant administration will be provided by the County Trip Reduction Program through the General Services Department.

Santa Cruz County Electric Bike Commuter Incentive Program Program Description Outline

Brief Background:

In June 1999, the Santa Cruz County Regional Transportation Commission (SCCRTC) concluded the area's *Major Transportation Investment Study* process and voted to include an electric bike program as one of the many projects planned to address regional transportation needs. The following October, Ecology Action of Santa Cruz was asked by the SCCRTC to become the lead agency in developing the electric bike program plan, which was recently completed as a team effort with the Santa Cruz Area Transportation Management Association.

General Program Description:

The purpose of the Santa Cruz County Electric Bike Commuter Incentive Program is to encourage the regular use of cost effective, appropriate electric transportation technology to reduce single occupancy auto trips, traffic congestion, neighborhood traffic volumes and speeds, parking demand and air pollution. Although the program will be offered to all residents of Santa Cruz County, key commute corridors and specific audiences within the County will be targeted to relieve traffic congestion during peak travel times. The program is intended to represent a creative collaborative effort among local government agencies, community based organizations and businesses. By combining attractive financial incentives, infrastructure support, promotion and education to encourage regular electric bike commuting, the program has been designed to be a model, with the intent of offering the fully developed format to other communities facing similar congestion issues.

Statement of Need and Primary Target Audience:

Santa Cruz County residents are encountering increased traffic congestion, as evidenced by longer commute times and increased neighborhood traffic volumes and speeds. According to national studies conducted by the transportation industry, 80% of all trips are less than 10 miles, and 50% of urban trips last less than 10 minutes. In Santa Cruz County, similar statistics have been documented through various commute surveys. In addition to creating significant traffic congestion, these "short commutes" result in a colder running gasoline or diesel motor that is less efficient and generates maximum pollutants.= The electric bicycle addresses the problems of costly and scarce parking, mobility difficulties during peak commute times in urban areas, air and noise pollution, and affordability of personal transportation,

Santa Cruz County combines several elements that make the community ideal for deploying a successful electric bicycle commuter incentive program. Key commute corridors are in an urban setting, a good percentage of the terrain is hilly, and the region enjoys fair weather nine or more months of the year. Local

government agencies and the SCCRTC have ensured a strong network of bike paths, lanes and storage, and their future commitment to further develop infrastructure for bike commuters over the next fifteen years.

The primary audience to be targeted for participation in the program are residents of the County who currently use a single occupied auto for short commutes. In the **Santa Cruz County Employee Commute Survey** conducted in the Spring of 1995, nearly 30% of the respondents who were driving alone to work or school indicated that they were willing to use a bicycle to commute, if the option were conveniently available.

Funding Plan:

With the, assistance of the SCCRTC staff, several funding sources have been secured thus far:

- The SCCRTC has supported the program development with a \$23,000 grant;
- . A Congestion Mitigation Air Quality grant sponsored by the SCCRTC was recently approved for \$380,000;
- Matching local in-kind resources totaling \$49,464 from sources other than CMAQ, SCCRTC or AB2766 grants will support the program over the next two years.

With an AB 2766 grant sponsored by the County of Santa Cruz, the Electric Bike Commuter Incentive Program will make an significant impact on traffic congestion in our community. Specifically, Ecology Action is requesting that the County sponsor a request for \$150,000 from the AB 2766 grant fund. The funds will be used as follows:

- 75% of the AB 2766 grant will be used to:
- offer a financial incentive in the form of a "subsidy/rebate" to SC County residents to purchase an electric bike for use'in commuting;
- (2) provide safety accessories (helmet, legal lights, lock, etc);
- (3) install solar charging/storage facilities strategically throughout the area;
- (4) pay for material expenses to promote the program.
- 25% of the AB 2766 grant will be used for staff time to do direct program coordination.

The CMAQ grant and local matching funds will also support each of these budget categories as well as provide the funding for administering the program.

FUNDING PLAN AND BUDGET NARRATIVE:

- This plan is consistent with the current approved funding from the SCCRTC Reserves and CMAQ.
- Funding shown is either approved or projected based on solid historical funding sources, with the exception of the AB2766 grant, which is in progress.
- If the AB2766 grant is successful, the local match for the CMAQ funds will be at 43% for FY 2000 through 2003. The match is shown in italics.
- The budget for equipment subsidies and safety accessories is adequate to subsidize 1300 bikes or \$300 per bike on average.
- Matching funds from the California Energy Commission and grants from PGE and others will add to the budget for solar charging/storage stations.



Lead Agency Experience and Community Partners:

The lead agency for this program is Ecology Action of Santa Cruz, coordinator of the Santa Cruz Area Bike To Work Project, and the Santa Cruz Area Transportation Management Association.
