RE: FUNDING REQUEST FOR PUBLIC ACCESS TV

Dear Members of the Board:

Attached is a letter from the Director of Community Television of Santa Cruz County outlining the expanded services provided by the agency and requesting one time funding from the County to replace their outdated and inadequate phone system, and to purchase a new switching system. As Board members are aware, the agency receives almost all of its very limited funding from AT&T Cable as part of their franchise agreement with the City of Santa Cruz and the County. With these limited funds, the agency provides three public access channels for the public and will soon be adding a fourth.

While I think it is appropriate that the cable companies pay the lion's share of the costs for operating the public access cable channels, I am sympathetic to the needs of this agency. Many demands have been placed on them and they have done an excellent job of responding to these demands despite their limited funding. For that reason, I am supportive of providing them limited one time funding to meet their critical capital needs.

Therefore, I recommend that the Board of Supervisors refer the funding request for \$37,636 in one time funding from Community Television of Santa Cruz County to the County Administrative Officer and direct that she return with a report and recommendation on this matter as part of the 2000-2001 Supplemental Budget.

Dear Chair Wormhoudt:

As you know, Community Television of Santa Cruz County has expanded its coverage of Santa Cruz County Government considerably in the past year, facilitating live coverage of your board meetings as well as other county commission meetings and hearings. The response to this coverage has been overwhelmingly positive; citizens throughout the County have expressed their appreciation for this "electronic expansion" of the democratic process. Our efforts in this regard have just been recognized by the League of California Cities and the California Center for Civic Renewal, both of which are honoring Community Television as a model for government access programming.

Community Television is also in the process of expanding its geographical coverage to include the cities of Watsonville, Capitola and unicoporated areas of South County currently served by Charter Communications, Inc.

In order to facilitate this expanded coverage and county-wide system, CTSCC, quite frankly, has been forced to assume several costs that were unanticipated at the founding of the organization. The necessities of programming a third channel to accommodate Board of Supervisors meetings-and the requisite technology it entailed-have severely impacted our capital reserves. We also have had to compensate with operational funds (i.e., staff time) for activities that might otherwise be automated.

I'd like to put our financial situation in some perspective for the Board: KQED's annual budget is \$32.5 million; KTEH's in San Jose is \$8.8 million. As you know, I have personally produced several programs for both stations. Those stations-program only one channel-compared to our three (and soon-to-be four)-and do not facilitate classes, live government programming, etc., as we do. KQED currently budgets approximately \$600,000 for a single, one-hour program-or the equivalent of our entire annual budget for 26,208 hours of programming, classes and community outreach.

I mention this because most people have no idea what television costs to produce these days. We do most of it with smoke and mirrors-and literally thousands of hours volunteered annually by staff and organization members. I have personally volunteered hundreds of hours towards our mission since 1997.

As a result of these fiscal contingencies, I am hoping you will consider one-time allocations for: 1) a new phone system; and 2) a new switching system for our playback operations. The cost of these proposals are as follows:

I have included formal bid proposals for both.

Our phone system is a relic that was previously discarded by the County. It does not meet the expanded needs of the community that we have experienced-and expect to experience-as a result of our expanded coverage. Given the more urgent demands of replacing television equipment, we do not have the funds to replace it.

The switching system presently in use will not facilitate the four-channel capacity that we will need to program the entire County. If we do not get the new switcher, we will not be able to unify the County's programming and will have to expend considerable staff resources to facilitate non-automated programming.
