ACCEPT UNANTICIPATED REVENUE AND AUTHORIZE APPROPRIATION TRANSFERS WITHIN THE JOB TRAINING PARTNERSHIP ACT (JTPA) BUDGET

Dear Members of the Board:

The CareerWorks Division of the Human Resources Agency (HRA) receives federal JTPA funds to operate a variety of local workforce development programs. On March 13, 2000, your Board accepted \$125,960 in unanticipated revenue attributable to Title II-A/C 5% Incentive funds awarded to CareerWorks by the State of California, Employment Development Department, under Agreement G96536 1. CareerWorks was recently notified of a \$7,33 1 increase to this Incentive award, specified as Employer-Assisted Benefits and Model Out-of-School Youth Incentive funds. This unanticipated revenue requires Board acceptance into the current JTPA budget.

In addition, CareerWorks is recommending a \$300,000 increase to funds designated for participant training (HRA Individual Referral to Occupational Skills), accommodated through appropriation transfers within the JTPA 396000 Budget Unit. CareerWorks' success in enrolling participants in occupational skills training, and the subsequent requirement to meet training commitments through June 30, 2000, necessitate the budget transfers.

IT IS THEREFORE RECOMMENDED that your Board adopt the resolution accepting unanticipated revenue in the amount of \$7,331 and authorize the transfer of budget appropriations as detailed in the attached AUD-74.
