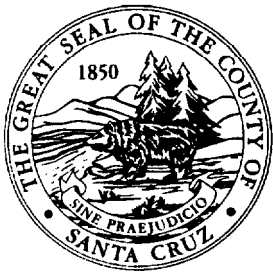


SUBJECT: COUNTY SERVICE AREA NUMBER 2, PLACE DE MER

WHEREAS, such additional funds are unanticipated revenue and not specifically set forth in the budget.


