
SUBJECT: PROPOSED NEW STOP SIGNS

Members of the Board:

The Public Works Department has been working with the Sheriffs Department and residents from the Mesa Verde area off of Green Valley Road to promote traffic safety improvements in their neighborhood. Our department is recommending the installation of five new stop sign locations for the Mesa Verde area. The first two stop signs are proposed at the Roberta Drive approaches to Arroyo Drive and Mark Avenue. Two more stop signs are proposed at the Ponderosa Avenue approaches to Jolon Drive and Mark Avenue. The remaining stop sign is proposed at the Jolon Drive approach to Mesa Verde Drive. All proposed stop signs meet stop sign warrants from the state traffic manual. A map of the proposed stop sign locations is attached for review by your Board. Over the next six months our department will evaluate the effectiveness of the proposed installation of the five new stop signs, and may return to your Board to recommend additional traffic safety improvements for the Mesa Verde area.

It is therefore recommended that the Board of Supervisors adopt the attached ordinance in concept for the installation of the proposed stop signs in the Mesa Verde area, and place it on the next available agenda for final adoption.



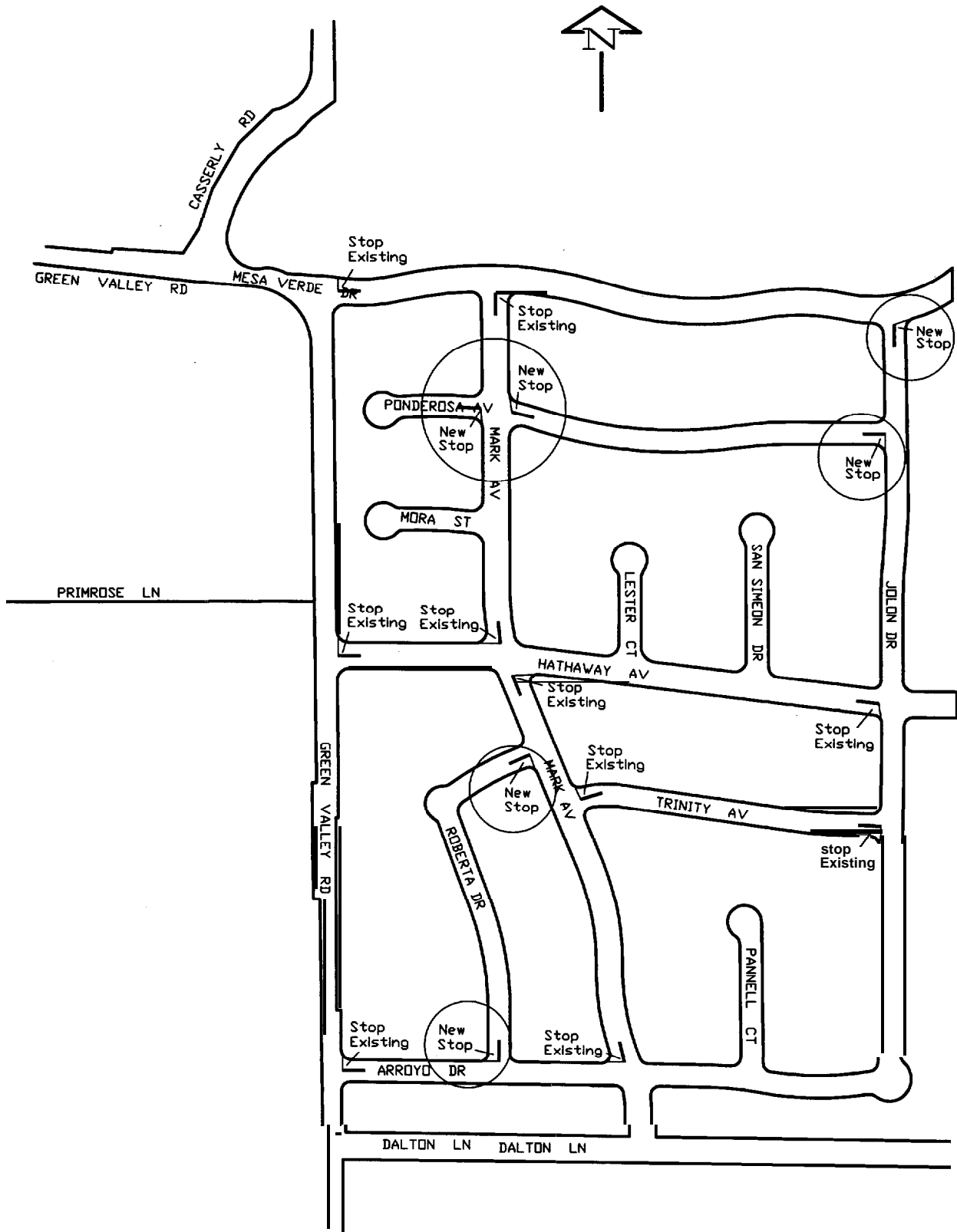
