RE: RECOMMENDATION OF AWARD FOR 1000 EMEMLINE RENOVATION #99C1-014

Members of the Board:

At the May 23, 2000 Board meeting, bids were received for the 1000 Emeline Renovation project. Your Board directed the General Services Department to review bids and award the contract to the lowest responsible bidder contingent upon adequate funding being available and review by the Auditor-Controller.

As directed, the bids received have been reviewed and we believe that the lowest bidder, Kase Pacific Construction, with a bid of \$779,900 can accomplish the work to the County's satisfaction. In addition to the contract amount, it is anticipated that a contingency amount of \$77,990 should be set aside for change order expenditures.

There are existing funds available in the Plant Budget, Index 191060, Sub Object 6610, User Code Q 30002 in the amount of \$734,000. In order to proceed with the project, an additional \$123,890 is necessary. The Human Resources Agency has the funding available in their Building Maintenance Budget. In order for these funds to be made available to the project, it is necessary to accept unanticipated revenue in the amount of \$123,890 into the Plant Budget.

- 1. Award a contract to Kase Pacific Construction in the amount of \$779,900 for the 1000 Emeline Renovation project;
- Authorize the General Services Director to notify the contractor and sign the 2. contract agreements and associated documents on behalf of your Board;
 - Approve the Resolution Accepting Unanticipated Revenue in the amount of 3. \$123,890, as detailed in the attached AUD 60; and,
 - 4. Authorize the Director of General Services to approve change orders and appropriate \$77,990 in addition to the contract amount to cover change order expenditures, as required.


