Members of the Board:

The plans, specifications and engineer's estimate for the Alto Drive Storm Damage Repair Project, County Service Area No. 44, are complete and presented here for your consideration and approval. The project provides for the repair of areas of damaged roadway and ditch shaping, which were damaged during the El Niño storm of March 1998.

The engineer's estimate for this project is \$17,000.00, not including contingencies and administration. Sufficient funds are included in the 2000/01 proposed budget to complete this work.

It is therefore recommended that the Board of Supervisors take the following action:

- Approve the plans, specifications, and engineer's estimate and authorize calling 1. for bids.
- Set bid opening for 10:45 a.m. on June 27, 2000.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning June 11, 2000, in accordance with provisions of the Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m.**, **JUNE 27, 2000**, and at **10:45** a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on Alto Drive in accordance with the specifications therefor, to which special reference is made, as follows:

The work to be done consists, in general, of repairing damaged areas of Alto Drive through **digouts** and grading and paving a roadside ditch as specified on the **sitemap** in the special provisions.

The successful bidder shall furnish a payment bond and a performance bond.

The contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
