TRANSFER OF FUNDS FROM PAJARO DUNES FIRE STATION MAINTENANCE FUND

Dear Members of the Board:

On November 19, 1991 your Board directed that excess funds from the Pajaro Dunes Fire Station Assessment District for construction of the Pajaro Dunes fire station be used to establish a fund for future maintenance of the fire station. A transfer of funds to address expenditures in the current fiscal year is being requested at this time.

During the current fiscal year,maintenance projects, including interior painting and deck repairs, totaling \$5,000 were completed. Appropriations from the Pajaro Dunes Fire (CSA 4 fund 22-250) operating budget were expended to cover these costs.

In a related project, a \$30,000 appropriation was approved in the current fiscal year for a generator to provide emergency back-up power to the station. The generator project will not go out to bid until Fiscal Year 2000/2001; therefore, the \$30,000 will not be expended in fiscal year 1999/2000. Although the appropriation was included in the operating budget, a recent bond attorney opinion concluded that the generator could appropriately be funded through the maintenance fund.

The Pajaro Dunes Community Affairs Committee has approved both the repairs and the purchase of the generator and are requesting a transfer of funds from the designated maintenance fund to cover these expenditures.

It is therefore RECOMMENDED that your Board:

1. Approve a transfer of funds in the amount of \$5,000 from the Pajaro Dunes Fire Station Assessment District Maintenance Fund (22-255) to the Pajaro Dunes Fire/CSA 4 Fund (22-250) for interior painting and deck repairs completed in 1999/2000 at the fire station; and,

- 2. Approve a transfer of funds in the amount of \$30,000 from the Maintenance Fund (22-255) to the CSA 4 Fund (22-250) for the generator project approved in Fiscal Year 1999/2000; and,
- 3. Approve the Resolution Accepting Unanticipated Revenue, as detailed in the attached AUD60.
