RE: Transfer of Funds and Resolution Accepting and Appropriating Revenue Sheriffs Office

Dear Members Of the Board:

The purpose of this letter is to request your Board's authorization to transfer funds and accept and appropriate revenue in order to meet obligations as they come due at year end in the Sheriff's budget. The attached documents transfer funds from the Sheriffs Operations budget to the Detention budget to cover costs associated with several necessary maintenance projects at the Main Jail and to cover costs for inmate food services. The attached resolution accepts and appropriates additional Proposition 172 revenue that is expected to be available this year to cover costs associated with Jail medical services and Jail supplies, such as cleaning, paper goods and the like.

IT IS THEREFORE RECOMMENDED that your Board approve the attached transfer of funds in the amount of \$100,000 within the Sheriff's Budget and adopt the attached resolution accepting and appropriating revenue in the amount of \$179,853.
