#### CONTRACT AMENDMENTS FOR HOMELESS ASSISTANCE SERVICES

#### Dear Members of the Board:

A number of programs providing shelter and support services for Santa Cruz County's homeless population were implemented successfully this past year with the assistance of grant funds. As in past years, HRA has executed agreements with state and federal funding agencies and then contracted with a local service provider for program implementation. Several of these contracts need to be modified at this time to realign funds within fiscal years or to extend the closing date of an agreement.

#### Winter Shelter - Contract #91763

This past year, the governor directed that the National Guard provide communities throughout the state with use of local armories for winter shelter at no charge through March 31, 2000. Just prior to the original closing date of the armories for shelter purposes, the National Guard notified counties and cities of the opportunity to extend use of these facilities for an additional fifteen days, through April 15, 2000. It was determined that the local service provider, the Santa Cruz Citizen's Committee for the Homeless/Interfaith Satellite Shelter Program would need an additional \$11,000 to extend associated shelter operations including maintenance, transportation, monitoring and janitorial services. The service provider was able to secure \$8,500 from various funding sources for this purpose, including \$2,500 from the City of Santa Cruz. Funds are available within the Homeless Assistance Budget, per Attachment A, to provide the additional \$2,500 needed for shelter-related services. HRA is recommending that contract #9 1763 with the Santa Cruz Citizen's Committee for the Homeless/Interfaith Satellite Shelter Program be

increased by \$2,500. This action will not result in any increase to net county costs.

#### Transitional Housing; at Community House - Contract #9 1554

Community House is a thirty-six month project funded through the U.S. Department of Housing and Urban Development (HUD) as part of that agency's focus on Continuum of Care programs. Community House features a transitional housing experience, including a variety of support services such as employment assistance, for homeless individuals seeking eventual permanent housing and self-sufficiency. Because program activities began several months after the contract start date, HUD has amended its agreement with HRA to extend the program through October of 2001, per Attachment B. As a result of this extension, the contract with the Santa Cruz Citizen's Committee for the Homeless needs to be extended four months by revising the fiscal year budget allocation, as described in Attachment C. A supplemental budget request for FY 2000/01 will also reflect this change.

#### Intake and Assessment - Contract #91488

The Intake and Assessment Project has been **funded** by the Department of Housing and Urban Development (HUD) for the past three years for a total of \$3 10,953. Unexpended **funds** fi-om FY 1997/98 in the amount of \$956 need to be appropriated and reallocated to FY 1999/00 to ensure that federal dollars are spent for project activities by the end of this fiscal year. A contract amendment and revised budget are included in Attachment D showing these changes. In addition, \$22,470 fi-om FY 1998/99 is being reallocated to FY 1999/00. These **funds** are already available in the Homeless Assistance Budget 391200 and will result in no increase to net county costs.

Upon completion of these fiscal actions, essential housing and support services will continue to be provided to homeless individuals and families within our community.

#### IT IS THEREFORE RECOMMENDED that your **Board** take the following actions:

- 1. Approve amendments to contract agreements # 91763, 91554 and 91488 for homeless assistance services;
- 2. Approve the modifications to **HRA's** agreement with HUD (Department of Housing and Urban Development) **#CA39B960802**; and
- 3. Approve the attached resolution accepting unanticipated revenue in the amount of \$956.00 to Index 391200, the Homeless Assistance Budget, for FY **1999/00**.

#### SUPPORTIVE HOUSING PROGRAM

This Grant Agreement Amendment is made this First day of February, 2000, by and between the United States Department of Housing and Urban Development (HUD) and the County of Santa Cruz of the State of California (the Recipient).

#### RECITALS

- 1. HUD and the Recipient entered into the Grant Agreement dated July 11, 1997, for the Community House.funded under HUD project number CA39B960802, stated in the Grant Agreement as located at 111 Coral Street in the City of Santa Cruz, California.
- 2. Under the **terms of** the Grant Agreement, Recipient received a grant from HUD in the amount of \$662,344, to be used to carry out the project described in the Grant Agreement over a. three year -period. The current grant ending date is October **31,2000**.
- 3. Recipient desires extension of the grant by one additional year for a revised ending date of October 31, 2001. The desired extension is demonstrated by written request to HUD. The Recipient has justified that the desired change (i) is to balance community needs for renewal funding, and (ii) that the extension is consistent with the operation and funding needs of the project.
- 4. The Recipient has cited the delayed completion of the construction and resulting delay in achieving full occupancy as the basis for lower than anticipated supportive services and operating costs. The Recipient recognizes that the preceding activities are partially funded by HUD, as demonstrated by the March 12, 1997, Technical Submission, approved by HUD on April 15, 1997. Accordingly, the Recipient has projected that it will have sufficient HUD funding to continue the Supportive Services and Operating activities for an additional year. The Recipient has represented to HUD that it has sufficient HUD and non-HUD funds to address all administrative needs for the remainder of the original grant period, and extension period upon full execution of this amendment.
- 5. By extending the grant period one additional year, the Recipient acknowledges that a minimum statutory share of 50 percent for eligible Operating activities applies during **the** extension period. The Recipient acknowledges to the definition of Operating **activities at** 24 CFR, Part 583 and that it will limit recovery of eligible Operating costs from HUD to no greater than 50 percent for the extension period.

- 6. The Recipient also acknowledges that the HUD-approved final year funding for Supportive Services and Operating activities, as stated in the HUD-approved April 15, 1997, Technical Submission, precedent to the Grant Agreement, are changed by extending the grant period one additional year. The Recipient acknowledges and agrees that the revised final year HUD-approved amounts for the preceding activities, Attachment A and B to this amendment, are the basis for renewal award computations.
- 7. HW has reviewed the initial application and the proposed change and has determined that, with the change, the application ranking would have been high enough to have been competitively selected in the year the application was initially selected.
- 8. The need for assistance for homeless persons continues within the jurisdiction within which the project is located and the need for the project continues.
- 9. HW has reviewed the project and the performance of the Recipient and has determined that the project is worthy of continuation.
- 10. HUD and the Recipient have agreed to amend the Grant Agreement to extending the grant for one additional year with a revised operating end date of October 31, 2001.

#### AGREEMENTS

- 11. The Grant Agreement is hereby changed by extending the grant to a fourth year with an ending date of October 31, 20001.
- 12. The effective date of this change is upon the full execution of this amendment.
- 13. The Recipient continues to agree to the provisions and terms of the Grant Agreement, except otherwise modified by this Grant Agreement Amendment Number 1, where applicable.
