On June 13, 2000, the Board of Supervisors received one bid for the Roy Wilson Maintenance Yard Well Replacement Project. The bid was found to be in order. The engineer's estimate was \$36,000. The low bidder was Maggiora Bros. Drilling, Inc. of Watsonville in the amount of \$38,480. Sufficient funds are available in the 1999/2000 budget to cover this expenditure plus contingencies and inspection.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of Maggiora Bros. Drilling, Inc. in the amount of \$38,480.00 and authorize the award of the contract.
2. Authorize the Director of Public Works to sign the contract on behalf of the County.
