Members of the Board:

On June 13, 2000, the Board of Supervisors received six bids for the Braemoor Drive Road Repair Project. All bids were found to be in order. The engineer's estimate was \$26,000. The low bidder was Earthworks of Santa Cruz in the amount of **\$23,343.75**. Sufficient funds are available in the County Service Area No. 47 budget to cover this expenditure plus contingencies and inspection.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of Earthworks in the amount of **\$23,343.75** and authorize the award of the contract.
2. Authorize the Director of Public Works to sign the contract on behalf of the County.


