Members of the Board:

The plans, specifications, and engineer's estimate for the subject storm damage repair project are now complete and presented herewith for your consideration and approval. The work provides for the repair of the 1996 storm site with the construction of rock slope protection and compacted earth embankment together with the necessary guard rail and drainage facilities.-

SUBJECT: IRWIN WAY, P.M. 0.49 - DSR NO. 5 1476, STORM DAMÁGE REPÁÍR

The project, as presented, addresses those repairs included in the approved Damage Survey Report (DSR), so as to return the damage site to its original pre-disaster condition. The plans and specifications thus provide for a repair which essentially matches the existing roadway in the vicinity of the repair site, pursuant to the Federal Emergency Management Agency's (FEMA) approved scope of work. In those instances where the funding approved for a DSR repair falls short of the actual bid price, we will submit a supplemental funding request to FEMA to reimburse the full cost of the repairs.

The engineer's estimate for this work is \$115,000.00, including contingencies and overhead costs. Sufficient funding for this project is available in the approved 1999/2000 Road Program by temporarily transferring \$50,000.00 from the Alta Via Road DSR project until such time as reimbursement is secured from FEMA.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids for the Irwin Way, P.M. 0.49 Storm Damage Repair Project.

- 2. Set the bid opening for 10:45 A.M. on June 20, 2000.
- 3. Direct the Clerk of the Board to advertise a Notice to Contractors for a fifteen-day period beginning May 28, 2000, in accordance with the provisions of Public Contract Code Section 20392.

This project'involves the construction of 1 tonne rock slope protection and earth embankment, including clearing and grubbing, earth excavation, asphalt pavement repair, metal beam guard rail, asphalt concrete dike, surface drainage facilities, fish & game protection facilities, and erosion control measures.

Plans, specifications. and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.

The contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
