### TRANSFER OF FUNDS FOR ADOPTION ASSISTANCE

Dear Members of the Board:

Your Board recently approved a transfer of funds and an increase of appropriations into the Categorical Aids budget unit as a result of mid-year estimated/actual budget estimates.

We now find that additional funds are needed to cover an unexpected increase in the number of authorized Adoption Assistance cases between April and May, 2000. Sufficient funds are available within the Categorical Aids Budget unit to cover a transfer of funds, with no additional cost to the county.

IT IS THEREFORE RECOMMENDED that your Board approve the transfer of \$20, 000 within the Categorical Aids 392200 budget per the attached AUD 74.
